Shall the Candia School District vote to approve the cost items included in an agreement to modify the 2023-2026 collective bargaining agreement reached between the Candia School Board and the Candia Education Association, which calls for the following increases in salaries and benefits at the current staffing levels over the amount that would be paid under the existing contract:

2024-2025 \$46,043

2025-2026 \$51,168

Project History

1. 2003 Design Charrette
 - Planning study of town center
 - Traffic concerns in Four Corners mentioned
2. 2014 Road Safety Audit
 - Cooperative review of issues and possible treatments at Raymond Rd intersections
3. 2017 Town Transportation Plan
 - Endorsed ideas from prior studies
4. 2019 Project selected for Ten Year Plan

Existing Conditions and Deficiencies

- Four Corners
 - AM and PM congestion on NH 43
 - Lack of sidewalks
- Raymond Rd intersections
 - Severe skew of both intersections
 - Difficult sight lines and awkward turns
 - High turning speeds
 - NH 43: 28 crashes from 2017-2021
 - 6 with injuries

Range of Alternatives

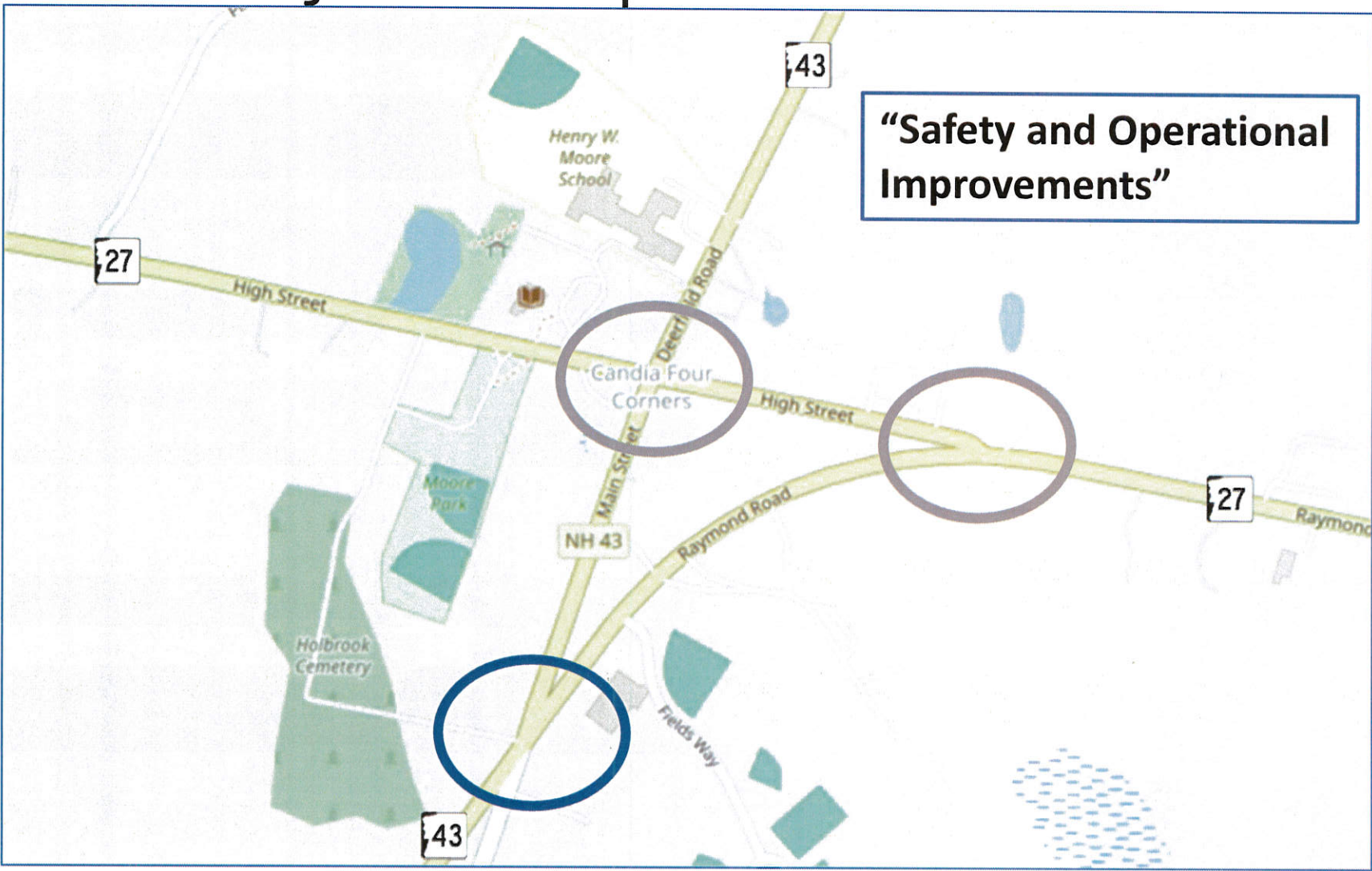
1. Raymond Rd intersections

- Improve intersection alignments
- Consider options for traffic control (stop signs, signals, roundabout)

2. Four Corners

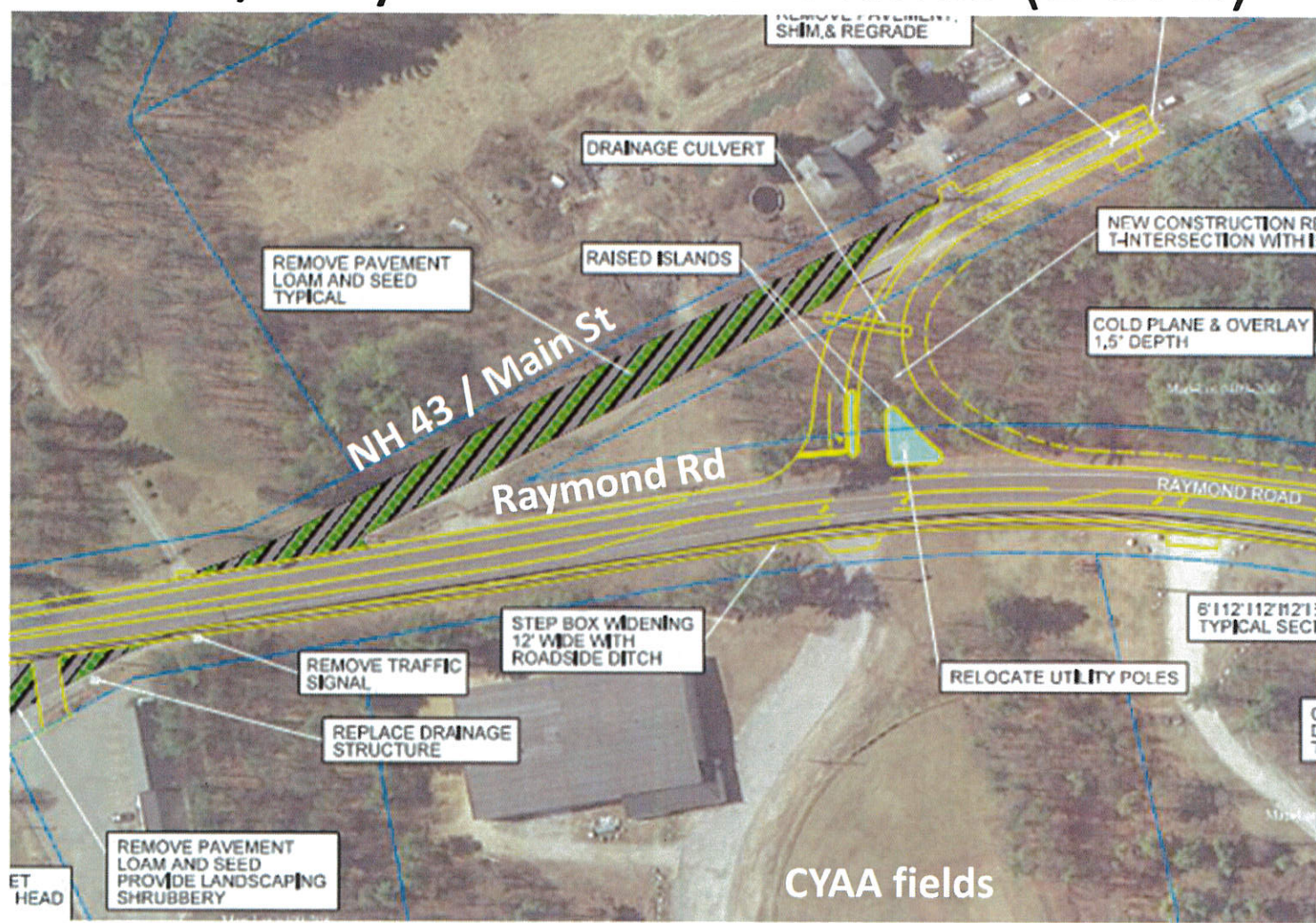
- Add sidewalks
- Consider signal control
- Mini-bypass

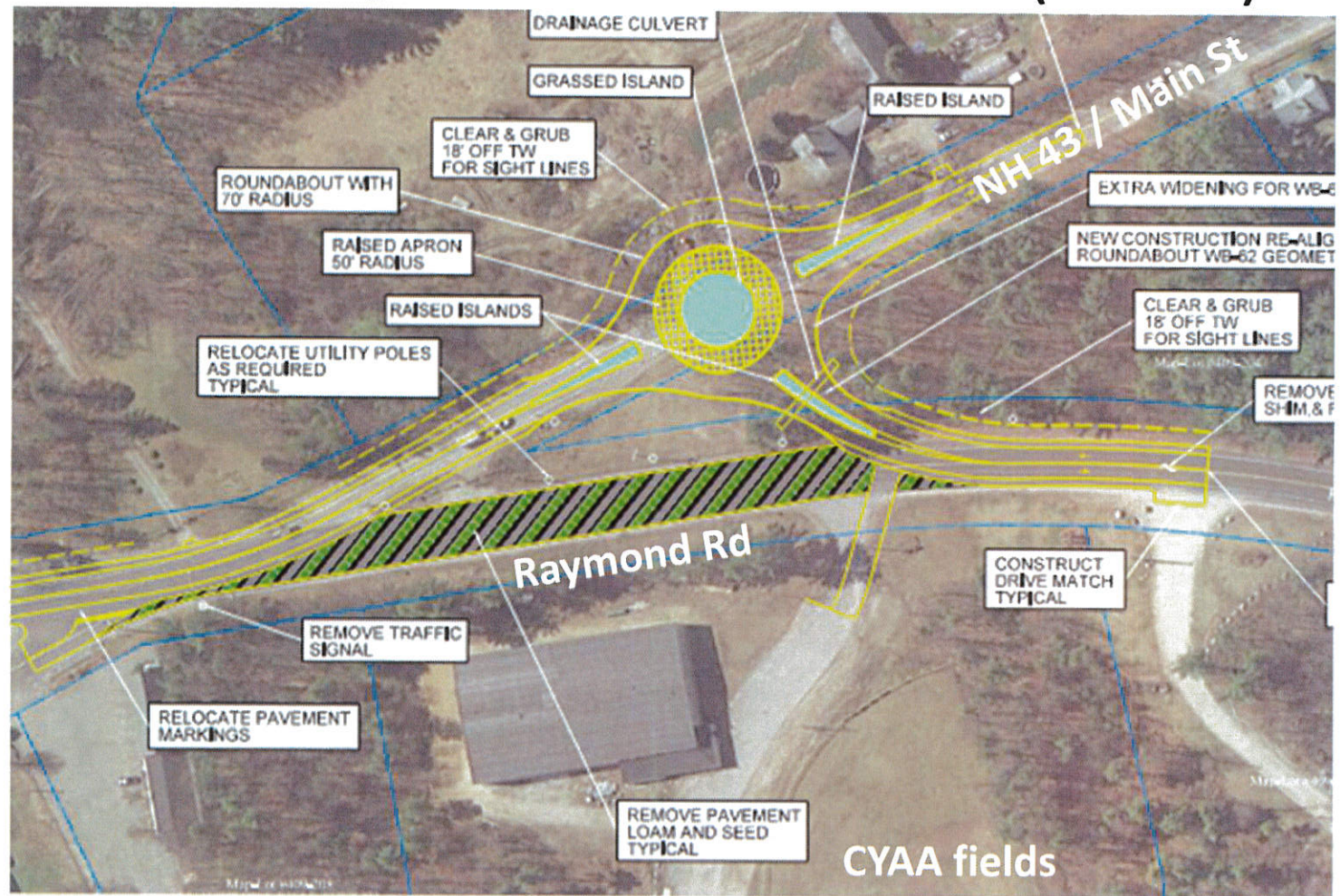

NH 43 / Raymond Rd Sketches (1 of 2)

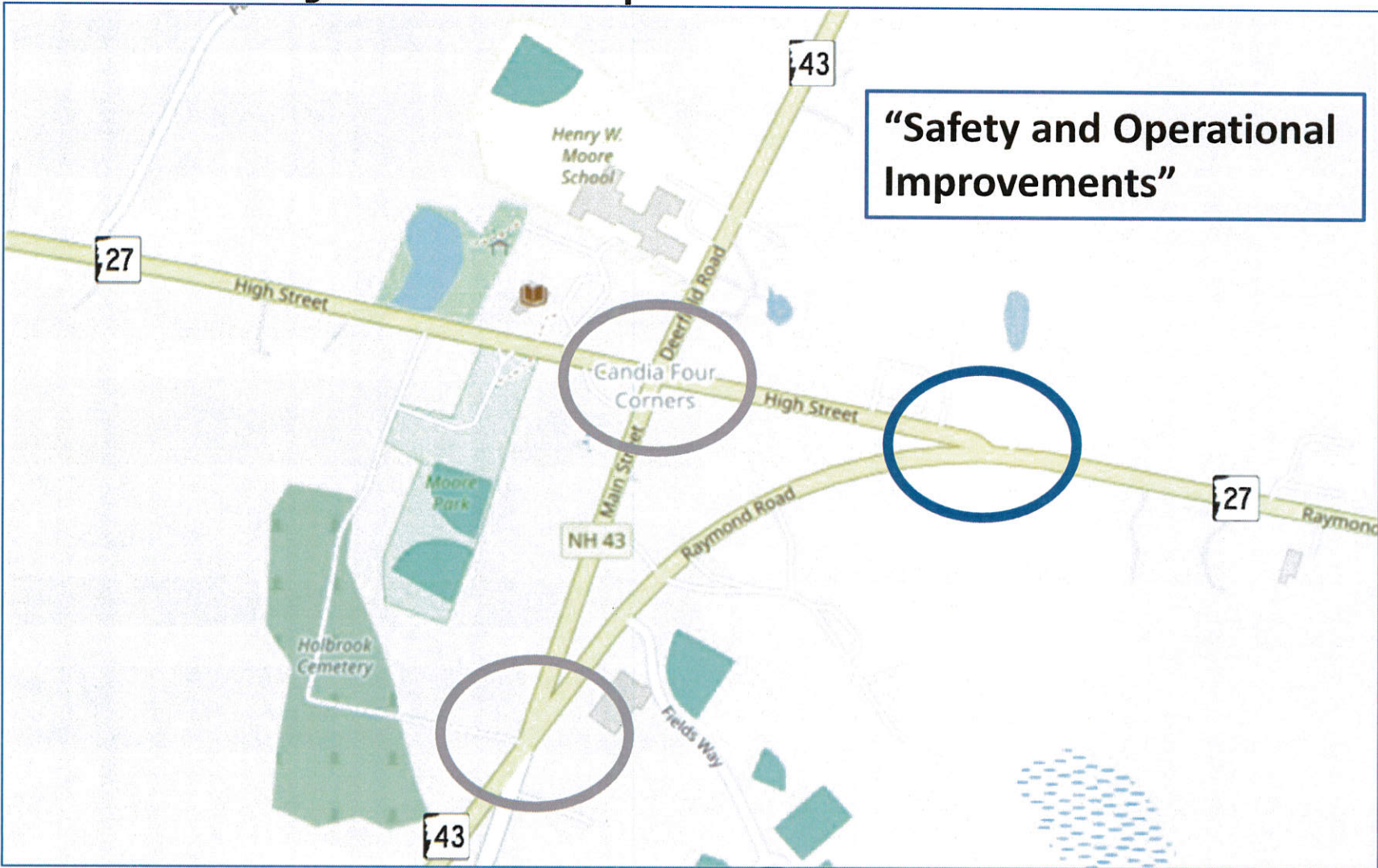

NH 43 / Raymond Rd Sketches (2 of 2)

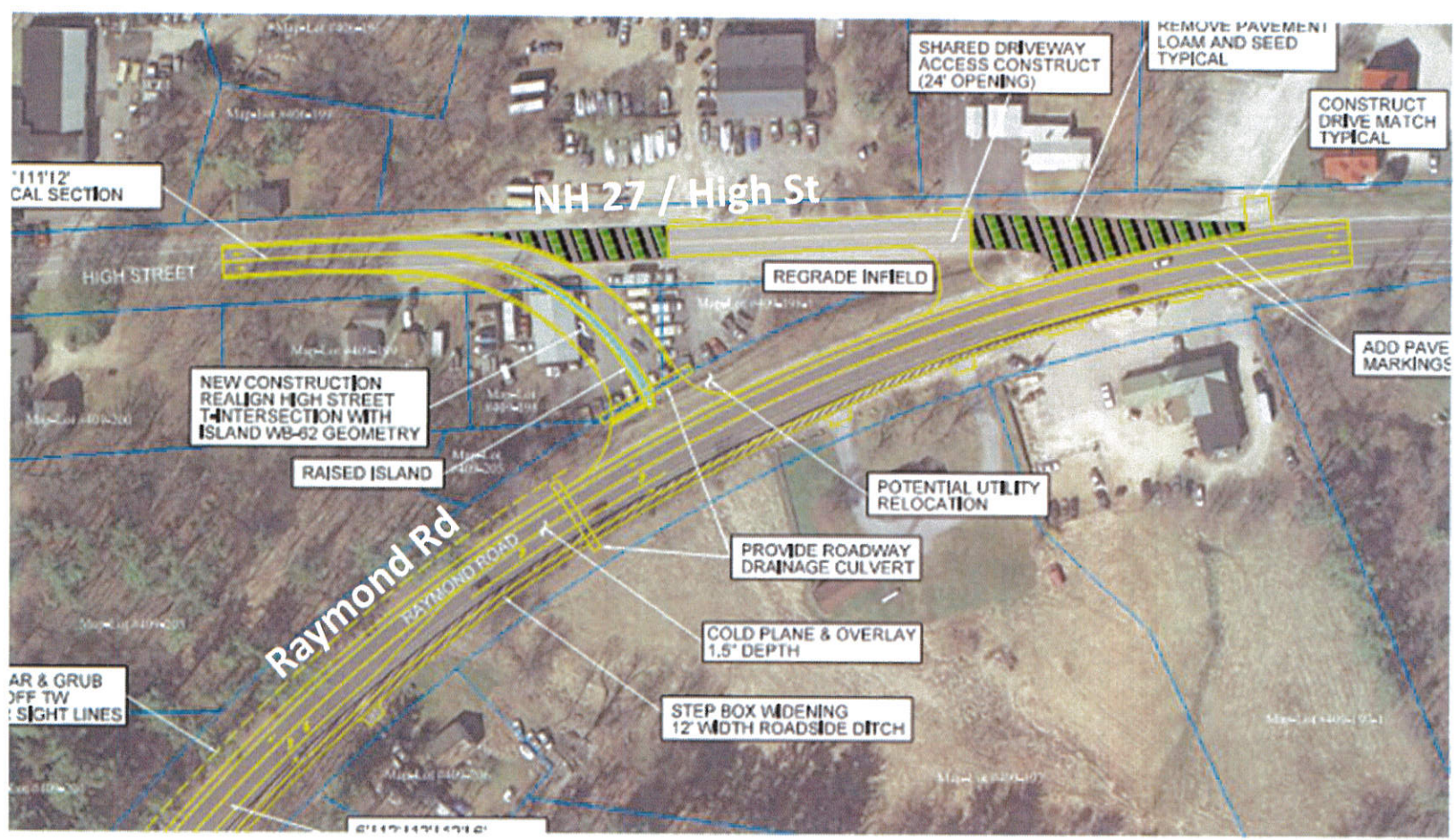
