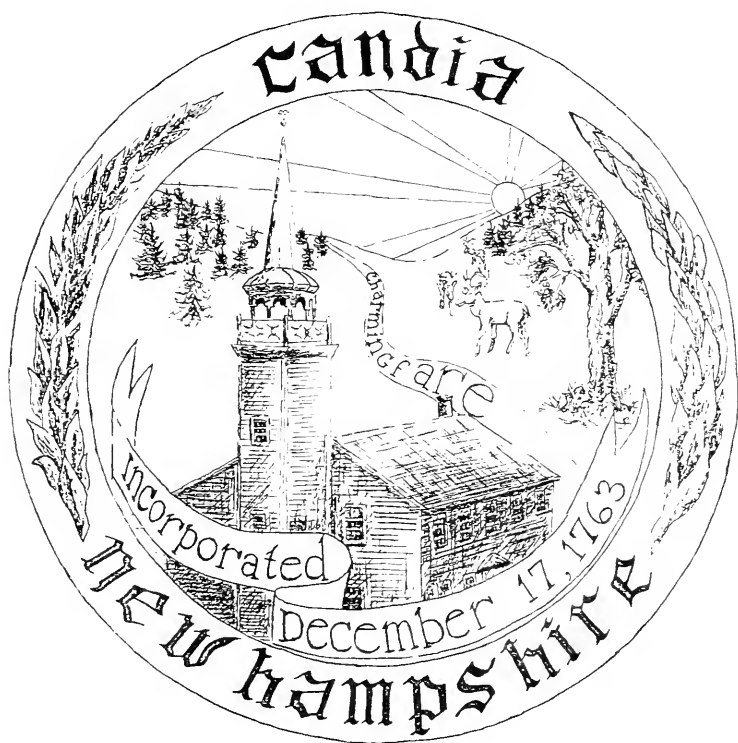

# **Town Warrant**

## **The State of New Hampshire**

THE POLLS WILL BE OPEN FROM 10:00 A.M. to 7:00 P.M.

TO THE INHABITANTS OF THE TOWN OF CANDIA, IN THE COUNTY OF ROCK-  
INGHAM, IN SAID STATE, QUALIFIED TO VOTE IN TOWN AFFAIRS:

You are hereby notified to meet at Moore School Auditorium in said Candia, on Tuesday the fourteenth of March next, at ten of the clock in the forenoon, to act upon the following subjects:

**Article 1.** To choose all necessary Town Officers for the year ensuing.

**Article 2.** To see if the Town will vote to adopt changes in zoning and building regulations proposed by the Planning Board and Petition to be voted by official ballot. Copies of proposals are available at the Town Clerk's office.

You are hereby notified to meet on Saturday the eighteenth of March next at nine of the clock in the forenoon at Moore School Auditorium to consider the following articles:

**Article 3.** To see if the Town will vote to raise and appropriate the sum of One Hundred Seventy-Four Thousand Three Hundred Fifty Dollars and no cents (\$174,350.00) for the purpose of constructing, furnishing and equipping of a Town Office Building to be located in Moore Park; said building to be constructed, furnished, and equipped using a negotiated contract basis with preference given to residents of the Town of Candia for the awarding of said contracts; One Hundred Seventy-Four Thousand Three Hundred Fifty Dollars and no cents (\$174,350.00) of such sum to be raised through the issuance of bonds or notes under and in compliance with the Municipal Finance Act, RSA 33:1 et seq., as amended; to authorize the Selectmen to invest said monies and use the earnings thereon for said project; to authorize the Selectmen to apply for, obtain and accept federal, state or other aid and donations, if any, which may be available for said project and to comply with all laws applicable to said project; to authorize the Selectmen to issue, negotiate, sell and deliver said bonds and notes and to determine the rate of interest thereon and the maturity and other terms thereof; and to authorize the Selectmen to take any other action or to pass any other vote relative thereto.

**Article 4.** To see if the Town will vote to transfer from the General Fund to the Town Office Building Capital Reserve Fund, the sum of Thirty-Five Thousand Dollars and no cents (\$35,000.00), previously raised and appropriated at the March 13, 1987, Town Meeting for the purchase of land for the Town Office Building; said sum now to be used for the constructing, furnishing and equipping of a Town Office Building.

**Article 5.** To see if the Town will vote to raise and appropriate the sum of One Hundred Seventy-Four Thousand Three Hundred Fifty Dollars and no cents (\$174,350.00) for the constructing, furnishing and equipping of a Town Office Building to be located in Moore Park; said building to be constructed, furnished and equipped using a negotiated contract basis with preference given to residents of the Town of Candia for the awarding of said contracts. (Article to be acted upon if Article 3 does not pass.)

**Article 6.** To see if the Town will vote to raise and appropriate the sum of Fifty Thousand Dollars and no cents (\$50,000.00) to be deposited in the Town Office Building Capital Reserve Fund. Said monies to remain in the Capital Reserve Fund until a Town Office Building Plan is approved by the Town. Further, to appoint the Board of Selectmen as agent to carry the purpose of the fund into effect pursuant to RSA 35: 15. (This article to be acted upon only if articles 3 and 5 do not pass.)

**Article 7.** To see if the Town will vote to disband the Town Office Building Committee and replace it with a Town Office Building Construction Committee. Said committee to contain one member each from the Board of Selectmen, Candia Police Department, and the Candia Volunteer Fire Department. Further, that representatives from the following trades be solicited to serve on this voluntary committee.

- a. Carpentry.
- b. Electrical.
- c. Plumbing and Heating.
- d. Excavation and Site Work.

(This article to acted on only if either Article 3 or Article 5 passes.)

**Article 8.** To see if the Town will vote to raise and appropriate the sum of Two Thousand Four Hundred Dollars and no cents (\$2,400.00) in continuation of its support for the services of the Lamprey Health Care, formerly Newmarket Regional Health Center.

**Article 9.** To see if the Town will vote to raise and appropriate the sum of Four Thousand Seven Hundred SeventyTwo Dollars and no cents (\$4,772.00) to be paid to the Visiting Nurse Association of Manchester and Southern New Hampshire, Inc. to defray the costs of the Agency's activities in the Town.

**Article 10.** To see if the Town will vote to raise and appropriate the sum of Six Hundred Fifty Dollars and no cents (\$650.00) to be paid to the Rockingham Child and Family Services to help maintain the existence of this agency as a social service for the Town.

**Article 11.** To see if the Town will vote to raise and appropriate the sum of One Thousand Seven Hundred Fifty-Eight Dollars and no cents (\$1,758.00) to the Rockingham County Community Action Program, Inc.

**Article 12.** To see if the Town will vote to raise and appropriate the sum of Twenty-Five Thousand Dollars and no cents (\$25,000.00) and deposit this amount in the Capital Reserve Fund, established at the 1988 Town Meeting, for the future revaluation of the Town. Further, to appoint the Board of Selectmen as agent to carry out the purpose of said Fund. Pursuant to RSA 35:15.

**Article 13.** To see if the Town will vote to raise and appropriate the sum of Sixteen Thousand, Five Hundred Dollars and no cents (\$16,500.00) in support of the Raymond Ambulance, Inc., for the provision of emergency medical service to the Town of Candia, for the ensuing year and to authorize the Board of Selectmen to enter into an agreement with the Raymond Ambulance, Inc. for said emergency services. By petition of 10 registered voters.

**Article 14.** To see if the Town will vote to raise and appropriate the sum of Eight Thousand Dollars and no cents (\$8,000.00) to be paid to Candia Rescue. Such funds to be expended under the direction of Candia Rescue and to be disbursed to Candia Rescue by April 30, 1989.

**Article 15.** To see if the Town will vote to raise and appropriate the sum of Thirty-Six Thousand Dollars and no cents (\$36,000.00) for fire suppression and prevention for the Town of Candia. The monies to be spent under the direction of the Candia Volunteer Firemen's Association, Inc. and to be received in full on or before April 30, 1989.

**Article 16.** To see if the Town will vote to raise and appropriate the sum of Thirty-Five Thousand Dollars and no cents (\$35,000.00). Twenty-Seven Thousand Dollars and no cents (\$27,000.00) for maintenance of emergency vehicles and equipment and Eight Thousand Dollars and no cents (\$8,000.00) for maintenance of the building and equipment where the emergency vehicles are housed. The monies to be spent under the direction of the Candia Volunteer Firemen's Association, Inc. and to be received in full on or before April 30, 1989.

**Article 17.** To see if the Town will vote to raise and appropriate the sum of Thirty-Six Thousand Dollars and no cents (\$36,000.00) for the operating expenses of the Smyth Public Library. These funds to be used for operating expenses of the Smyth Public Library. These funds to be expended under the direction of the trustees of the Smyth Public Library Association of Candia.

**Article 18.** To see if the Town will vote to raise and appropriate the sum of Seven Thousand Five Hundred Dollars and no cents (\$7,500.00) to the Candia Police Department for the purchase of new hand guns and necessary leather gear to equip the department with Town owned weapons. Said monies to be spent under the authorization of the Board of Selectmen.

**Article 19.** To see if the Town will vote to raise and appropriate the sum of Twelve Thousand Eight Hundred Fifteen Dollars and no cents (\$12,815.00) to the Candia Police

Department for the purpose of hiring a full time police officer.

**Article 20.** To see if the Town will vote to raise and appropriate the sum of Ten Thousand Dollars and no cents (\$10,000.00) to be used for start-up costs of a glass recycling program and further to use these funds or part thereof for any matching grants that may become available for recycling.

**Article 21.** To see if the Town will vote to raise and appropriate the sum of Three Thousand Dollars and no cents (\$3,000.00) for the purpose of connecting the plumbing of the well and septic system located at the town hall at Moore Park to the Doucette field house. By petition of 13 register voters.

**Article 22.** To see if the Town will vote to raise and appropriate the sum of Five Thousand Dollars and no cents (\$5,000.00) for the purpose of adding a well at Moore Park. By petition of 13 registered voters.

**Article 23.** To see if the town will vote to raise and appropriate the sum of Eight Thousand Dollars and no cents (\$8,000.00) for the purpose of adding lights or a septic system at Moore Park. By petition of 12 registered voters.

**Article 24.** To see if the Town will vote to establish a Capital Reserve Fund for future use in recreation, open space, conservation land acquisition or improvement, or for matching State or Federal funds which may be available for these purposes. Further to see if the town will vote to raise and appropriate the sum of Ten Thousand Dollars and no cents (\$10,000.00) and deposit this amount in the fund. The specific uses of fund so reserved are subject to approval by the voters of the Town of Candia at a Town meeting.

**Article 25.** To see if the Town will vote to accept that portion of the budget not already acted upon and raise and appropriate the sum of One Million Eighty-Four Thousand Six Hundred Fifty-Three Dollars and no cents (\$1,084,653.00).

**Article 26.** To see if the Town will vote to adopt an ordinance regulating the disposal of solid waste at the incinerator facility as authorized under RSA 149-M and RSA 31:39. The complete text of the proposed Candia Solid Waste Ordinance is printed in the town report.

**Article 27.** To see if the Town of Candia Will vote to place the Candia Boston Post Cane on display at the Fitts Museum until a permanent site can be provided in a Town Office Building. Further to request that Candia Historical Society assist in recording and honoring Candia's eldest citizens in some appropriate manner.

**Article 28.** To see if the Town will vote to adopt Educations Tax Credit Procedure.

Format:

Beginning July 1, 1989, any owners of real estate in Candia who pays all or part of a private High School tuition for any Candia resident may be eligible pursuant to RSA 76:16, to receive a tax abatement from the Town of Candia in an amount not to exceed \$1,000.00 or 85% of their last Candia Property tax bill, whichever is the lesser amount.

Conditions of Eligibility:

1. Individuals seeking an abatement must provide the Town with the following information:
  - A. Name and address of the student whose tuition has been paid.
  - B. Proof that the student is a resident of the Town of Candia.
  - C. Proof of tuition payment.
2. The total amount of the abatement(s), if granted, shall not exceed \$1,000.00 for any one student.
3. Individuals, who sponsor students who transfer from a public high school system to a private high school system during the same school year, will have any abatements, if granted, prorated according to the number of weeks the student is enrolled in the private high school system.
4. Individuals, who sponsor students who transfer from a private high school system to Candia's public school system during the same school year, shall be ineligible for an abatement under the terms of this program.

This warrant article submitted by petition of 120 registered voters.

**Article 29.** To see if the Town is in favor of a three (3) year term for the Town Road Agent of Candia, term to begin in March 1990, pursuant to RSA 231:62-a.

**Article 30.** We the undersigned, in compliance with RSA 231:157, scenic roads; designation and RSA 231:158, effect of designation as scenic roads, hereby Petition to see if the town of Candia will vote to designate CRITCHETT ROAD (beginning at the intersection of Old Deerfield Road and New Boston Road and travelling approximately two and two-tenths miles easterly along rangeway number one to the Raymond town line) as a scenic road for the purpose of prohibiting the removal of ornamental and shade trees or the undermining, tearing down, or destruction of stone walls, or portions thereof, in order to protect the natural scenic beauty and character of the Town of Candia. By petition of 12 registered voters.

**Article 31.** To see if the Town will vote to authorize the Selectmen to apply for, accept and expend without further action by the Town Meeting, money from the State, Federal or other Governmental unit or a private source which becomes available during the fiscal

year, pursuant to RSA 31:95-b.

**Article 32.** To see if the Town will vote to authorize the Town to accept such funds as are made available to the Candia Forest Fire Warden, under the Rural Development Act of 1972, Title IV.

**Article 33.** To see if the Town will vote to authorize the Treasurer with the approval of the Selectmen to negotiate temporary loans in anticipation of taxes.

**Article 34.** To see if the Town will vote to accept such trust funds as have been received this past year.

**Article 35.** To see if the Town will vote to authorize the Selectmen to administer or convey by auction or advertised sealed bids, any real estate acquired by the Town through Tax Collector's deed. Pursuant to RSA 80:42.

**Article 36.** To transact any other business that may legally come before said meeting.

# ANNUAL TOWN MEETING

TOWN OF CANDIA, N.H.

MARCH 11, 1988

Moderator A. Ronald Thomas declared the meeting to be in session at 7:36 PM, on the eleventh of March, 1988. Mr. Thomas, who stated he had been criticised for not having a gavel at the podium, then brought out and blew his attention getting device-a train whistle. Results of the March 8 elections were then read for the benefit of those assembled who had not yet heard the results. Mr. Thomas reviewed the basic ground rules to the assembly. The following Town Officers and staff were introduced: Chris Dupere, Town Clerk, Donald Coleman, Selectman, John Thomson, Selectman, Don Belcourt, Selectman, Diane LaCombe, Secretary, Bonnie Hyler, Secretary, and Bart Mayer, Town Counsel. Since there was no objection from the floor, the following non-registered voters will be allowed to speak for informational purposes: Bart Mayer, Town Counsel, Damien Turner, HTA Associates, Chandler Newton and Richard Audette of Raymond Ambulance Association. A modified set of Robert's Rules of Order will be used for the meeting.

Mr. Coleman was recognized for the purposes of a resolution. At this time, a plaque was presented to Irvine Whitcomb for his many years of service to the Town of Candia. The inscription on the plaque reads as follows: In appreciation for Thirty-five years of dedication as Trustee of Trust Funds for the Town of Candia, presented to Irvine Whitcomb, Town Meeting, March 11, 1988. Mr. Whitcomb stated that after thirty-five years, it was time he quit. He has been very happy and has great people to work with, and is now happy it's all over.

**Article 3.** To see if the Town will vote to raise and appropriate the sum of Four Hundred Thousand Dollars and no cents (\$400,000.00) for the construction and furnishing of a Town Office Building. Further, to authorize the Selectmen to negotiate the issuance of bonds or serial notes according to such conditions as the Selectmen deem prudent, pursuant to New Hampshire RSA 33. Motion was made by Mike McRae to accept the article as read, and seconded by James Gatcomb. Mr. McRae was then recognized to speak to the article. Helen Wilson then made a motion to ammend the article to read: To see if the Town will vote to raise and appropriate the sum of Four Hundred Thousand Dollars and no cents (\$400,000.00) for the construction and furnishing of a Town Office Building. Motion was seconded by Richard Snow. Mrs. Wilson then spoke to the article, explaining that the tax burden would be for only one year, instead of over a five year period. In this way we would save over \$71,000.00 in interest charges which would be the result of a bond issue. After another period of discussion, a motion to move the question was made by Sue Young, and seconded by Judy Szot. Mr. Thomas then explained that if 2/3 vote yes, we end discussion on the ammendment and proceed to vote on the ammendment to the article, which would be to pay for the Town hall in one year rather than a Bond Issue. The vote is 2/3 and we move to a vote on ammended article 3: To see if the Town will vote to raise and appropriate the sum of Four Hundred Thousand Dollars and no cents (\$400,000.00) for the construction and furnishing of a Town Office Building. The am-



amendment is defeated. Discussion on article 3 resumes. Diana Watts then made a motion to ammend article 3 to read: To see if the Town will vote to raise and appropriate the sum of Three Hundred Thousand Dollars and no cents (\$300,000.00) for the construction and furnishing of a Town Office Building. Further to authorize the Selectmen to negotiate the issuance of bonds or serial notes according to such conditions as the Selectmen deem prudent, pursuant to New Hampshire RSA 33. Motion was seconded by Eric Purington. When this ammendment was put to a vote, it was also defeated. Todd Binns then made a motion to move the question on Article 3. This was seconded by Bill Zarges. The motion to move to a vote on the Bond Issue passed. Mr. Thomas then declared a four minute and thirty second recess to prepare for the vote on the Bond Issue. He also explained the procedure for voting and introduced Normand St. Onge as Assistant Moderator, to assist with the polls. Polls opened at 9:18 PM, and were declared closed at 10:26 PM. Final votes were as follows: 105 YES, and 251 NO. ARTICLE 3 is DEFEATED.

A motion was proposed by Neil Sieminski, so that Article 20 will follow Article 3. This motion was seconded by Ingrid Byrd. Mr. Sieminski was then recognized to speak to his motion, explaining that if it remained in the order given, most people would have left the assembly. A majority vote is required to next consider Article 20. The change in order was passed, Article 20 will be considered next.

**Article 20.** To see if the Town will vote to accept that portion of the budget not already acted upon and raise and appropriate the sum of One Million Fifty-two Thousand Four Hundred Thirty-one.Dollars and no cents (\$1,052,431.00). Motion to accept the article as read was made by Don Coleman and seconded by Don Belcourt. Mr. Coleman was then recognized to speak to the motion. A lengthy period of questions and answers then ensued. Jon Godfrey then made a motion to ammend Article 20 to read to see if the Town will vote to accept that portion of the budget not already acted upon and raise and appropriate the sum of Seven Hundred Fifty-two Thousand Dollars and no cents (\$752,000.00). The motion was seconded by Sue Young. Mr. Godfrey then spoke to the ammendment, stating that this figure would give the Town a fifteen percent increase over last year's budget. A motion to move the question was made by Gary Cote and seconded by Mr. Byrd. The vote passes to move the question. We now move to a vote on the ammended Article 20, which makes the article read as follows: TO see if the Town will vote to accept that portion of the budget not already acted upon and raise and appropriate the sum of Seven Hundred Fifty-two Thousand Dollars and no cents (\$752,000.00). The ammendment was then put to a vote and passed. Discussion was then opened on the ammended Article 20. Todd Binns made a motion to move the question, which was seconded by Judy Szot. The vote on moving the question passes; we move to a vote on Article 20. Article 20 as ammended is ADOPTED.

**Article 4.** To see if the Town will vote to raise and appropriate the sum of Fifty Thousand Dollars and no cents (\$50,000.00) to be deposited in the Town Office Capital Reserve Fund. Said monies to remain in the Capital Reserve Fund until a Town Office Building Plan is approved by the Town. Further, to appoint the Board of Selectmen as agent to

carry the purpose of the fund into effect. Pursuant to RSA 35:15. Motion was made by Mike McRae to accept the article as read, and seconded by James Gatcomb. Mr. McRae was recognized to speak to the article. After a brief discussion, Mr. Gatcomb wished to move the question; this was seconded by Elliot Hardy. The motion passes. The vote on Article 4 was taken by standing vote: 152 YES, 118 NO. Article 4 is ADOPTED.

**Article 5.** To see if the Town will vote to raise and appropriate the sum of One Thousand Dollars and no cents (\$1,000.00) to support the services of the Fitts Museum. The money to be spent under the direction of the Trustees of the Fitts Museum. Motion was made by Mabel Brock to accept the article as read, and seconded by Gordon Jester. There was no discussion on this article, and when put to a vote, Article 5 was ADOPTED.

**Article 6.** To see if the Town will vote to raise and appropriate the sum of Two Thousand Two Hundred Dollars and no cents (\$2,200.00) in continuation of its support for the services of the Lamprey Health Care, formerly Newmarket Regional Health Center. Motion was made by Don Coleman that the article be accepted as read, and seconded by John Thomson. Mr. Coleman reviewed the services of Lamprey Health Care, and when put to a vote, Article 6 was ADOPTED.

**Article 7.** To see if the Town will vote to raise and appropriate the sum of Four Thousand Three Hundred Forty-eight Dollars and no cents (\$4,348.00) to be paid to the Visiting Nurse Association of Manchester and Southern New Hampshire, Inc. to defray the costs of the Agency's activities in the Town. Motion was made by Janet Manter to accept the article as read, and seconded by Helen Kendall. Mrs. Manter was then recognized to speak to the article. When put to a vote, Article 7 was ADOPTED.

**Article 8.** To see if the Town will vote to raise and appropriate the sum of Five Hundred Dollars and no cents (\$500.00) to be paid to the Rockingham Child and Family Services to help maintain the existence of this agency as a social service of the Town. Motion was made by Don Coleman to accept the article as read, and seconded by Don Belcourt. There was no discussion, and when put to a vote, Article 8 was ADOPTED.

**Article 9.** To see if the Town will vote to raise and appropriate the sum of One Thousand Six Hundred Sixty-one Dollars and no cents (\$1,661.00) to the Rockingham County Community Action Program, Inc. Helen Wilson was recognized for the purposes of a motion, which was seconded by Bill Zarges. There was no discussion, and when put to a vote, Article 9 was ADOPTED.

**Article 10.** To see if the Town will vote to appropriate the sum of One Thousand One Hundred Twenty-five Dollars and Seven cents plus interest (\$1,125.07) to close the Revenue Sharing Account, for the reconditioning and preservation of Town Clerk's Records, Volumes 3 and 4, and authorize the withdrawal of the amount required for this purpose from the Federal Revenue Sharing Fund. Christine Dupere made a motion to accept the article as read. The motion was seconded by Don Coleman. Chris Dupere then spoke to the article,

explaining the restoration process and exhibiting one of the completed volumes dating from 1743. Janet Manter ammended the article to read as follows: To see if the Town will vote to appropriate the sum of One Thousand One Hundred Twenty-five Dollars and Seven cents (\$1,125.07) for the reconditioning and preservation of Town Clerk's Records Volumes 3 and 4 and to authorize the withdrawl of this amount from the Federal Revenue Sharing Fund. The ammendment was seconded by Mrs. Benz. There was no discussion on the ammendment, and when put to a vote, the ammendment passes. There was no additional discussion on the ammended Article 10, and when put to a vote the article was ADOPTED.

**Article 11.** To see if the Town will vote to raise and appropriate the sum of Sixteen Thousand Five Hundred Dollars and no cents (\$16,500.00) in support of the Raymond Ambulance Inc. for the provision of emergency medical service to the Town of candia, for the year of January 1, 1988 thru December 31, 1988 and to authorize the Board of Selectmen to enter into an agreement with the Raymond Ambulance Inc. for said emergency services. Don Coleman made a motion to accept the article as read. This was seconded by Don Belcourt. Chandler Newton was then recognized to speak to the article. Those using the service will now be charged for the service. Raymond Ambulance has served the Town of Candia for the past twenty-nine years. Richard Fitts then made a motion to ammend Article 11 as follows: To see if the Town will vote to raise and appropriate the sum of Sixteen Thousand Five Hundred Dollars and no cents (\$16,500.00) for the purpose of providing ambulance service to the Town of Candia. Said service shall be chosen based on written proposals submitted to the Board of Selectmen. This article also authorizes the Board of Selectmen to enter into a contract agreement with the chosen ambulance service company. Motion was seconded by Les Cartier. Discussion centered on the need for advanced life support systems and an ambulance manned by attendants with the same or higher skill levels than the Candia Rescue. After further discussion, the ammendment to Article 11 was put to a standing vote. 127 YES, 90 NO; the article is ammended. There was no further discussion on the ammended article, and when put to a vote, Article 11 was ADOPTED.

**Article 12.** To see if the Town will vote to establish a capital reserve fund (pursuant to Chapter 35) for the future Revaluation of the Town and to appoint the Board of Selectmen as the agents to carry out the purposes of such fund. Further, to see if the town will vote to raise and appropriate the sum of Twenty-Five Thousand Dollars and no cents (\$25,000.00) and deposit this amount in the fund. Motion was made by Don Coleman to accept the article as read, and seconded by Don Belcourt. Mr. Coleman then spoke to the article stating we were on the schedule to be revaluated in 1991. After further discussion, Sue Young wished to move the question. This was seconded by Jim Gatcomb, and when voted upon, was passed. Article 12 was then voted on and ADOPTED.

**Article 13.** To see if the Town will vote to raise and appropriate the sum of Eight Thousand Dollars and no cents (\$8,000.00) to be paid to Candia Rescue. Such funds to be expended under the direction of Candia Rescue and to be disbursed to Candia Rescue by April 30, 1988. Motion to accept the article as read was made by Richard Fitts and seconded

by Les Cartier. Mr. Fitts was then recognized to speak to the motion. After a brief discussion, the article was put to a vote, and was ADOPTED.

**Article 14.** To see if the Town will vote to raise and appropriate the sum of Thirty Four Thousand Dollars and no cents (\$34,000.00) for fire suppression and prevention for the Town of Candia. The monies to be spent under the direction of the Candia Volunteer Firemen's Association, Inc. and to be received in full on or before April 30, 1988. Len Wilson made a motion to accept the article as read, and this was seconded by Jim Wilson. Len Wilson then wished to amend the article to read as follows: and in addition, to see if the Town will vote to raise and appropriate the sum of Ten Thousand Dollars and no cents (\$10,000.00) for the maintenance of one 1972 Mack tanker. The monies shall be spent under the direction of the Candia Volunteer Firemen's Association, Inc. with payment being made upon completion and acceptance by the Candia Volunteer Firemen's Association, Inc. for each phase of maintenance. Motion was seconded by James Wilson. In this way, Mr. Wilson has amended Article 14 to include Article 15. The DRA had stated to the Selectmen that money cannot be voted for the refurbishment of trucks. With the combination and re-wording of the articles, however, monies can be voted in to maintain the truck. The money would therefore be appropriated for the operation of the Department. Len Wilson then wished to withdraw his amendment, and was permitted to do so. He then made a motion for the following amendment: To see if the Town will vote to raise and appropriate the sum of Forty-Four Thousand Dollars and no cents (\$44,000.00) for fire suppression and prevention for the Town of Candia. The monies to be spent under the direction of the Candia Volunteer Firemen's Association, Inc. and to be received in full on or before April 30, 1988. Motion was seconded by Jim Wilson. After discussion on the amended Article 14, a vote was taken and the amendment is ADOPTED. Mr. Belcourt then made a motion to amend the amended Article 14 to read: to see if the Town will vote to raise and appropriate the sum of Fifty Four Thousand Dollars and no cents for fire suppression and prevention for the Town of Candia. The monies to be spent under the direction of the Candia Volunteer Firemen's Association Inc. and to be received in full on or before April 30, 1988. This amendment was seconded by Bill Zarges. Mr. Belcourt explained that the additional money could be used to do both trucks this year. Mr. Wilson, however, pointed out that this amount would not be sufficient, which was the reason they only wanted enough to do one truck this year and would ask for monies for the other truck next year. Mr. Belcourt then wished to change his amendment to read Sixty Four Thousand Dollars and no cents (\$64,000.00), which would cover both vehicles. This was seconded by Donna St. Onge. Following more discussion on the increase, Janet Wildeman made a motion to move the question. This was seconded by Mrs. St. Onge. Vote to moving the question passes. We move to a vote on the amendment to Article 14, which would raise the amount to \$64,000.00. The amendment FAILS. Discussion was then re-opened on Article 14. Donna St. Onge wished to move the question, and this was seconded by Boyd Chivers. The vote to move the question passes. A vote will now be taken on Article 14, which reads as follows: To see if the Town will vote to raise and appropriate the sum of Forty Four Thousand Dollars and no cents (\$44,000.00) for fire suppression and prevention for the Town of Candia. The monies to

be spent under the direction of the Candia Volunteer Firemen's Association, Inc. and to be received in full on or before April 30, 1988. Article 14 is ADOPTED.

**Article 15.** Leonard Wilson made a motion to indefinitely table Article 15. This was seconded by Clarence Blevens. Vote to table the article PASSES.

**Article 16.** To see if the Town will vote to raise and appropriate the sum of Thirty Two Thousand Dollars and no cents (\$32,000.00) for the operating expenses of the Smyth Public Library. These funds to be used for operating expenses of the Smyth Public Library. These funds to be expended under the direction of the trustees of the Smyth Public Library Association of Candia. Mary Caddy made a motion to accept the article as read, and this was seconded by Barbara Bowman. Mrs. caddy was then recognized to speak to the article. There was no further discussion, and when voted upon, Article 16 was ADOPTED.

**Article 17.** To see if the Town will vote to raise and appropriate the sum of Four Thousand Five Hundred Dollars and no cents (\$4,500.00) for the purpose of upgrading the existing field at Moore Park to fulfill the Little League regulations for baseball fields. Motion was made by Ernie Lefebvre to accept the article as read, and seconded. by Paul Labelle. Mr. Lefebvre then spoke to the article, discussing the growth of the Town and the growth of participation in Town athletic programs. With this money, the field would be graded and leveled, and then re-seeded. Additional monies would be raised by the Candia Youth Athletic Association. After brief discussion, Helen Wilson wished to move the question. This was seconded by Dr. Sander. The motion to move the question passed. When put to a vote, Article 17 was ADOPTED.

**Article 18.** To see if the Town will vote to raise and appropriate the sum of Ten Thousand Dollars and no cents (\$10,000.00) to the Smyth Public Library Association of Candia. These funds to be used for building repairs to the roof and foyer of the Smyth Public Library. These funds to be expended under the direction of the trustees of the Smyth Public Library Association of Candia. Motion was made by Mary Caddy and seconded by Marjorie Benz to accept the article as read. Mrs. Caddy then spoke to the article. After a brief explanation of how the funds would be used, the article was put to a vote and Article 18 was adopted.

**Article 19.** To see if the Town will vote to raise and appropriate Thirteen Thousand Dollars and no cents (\$13,000.00) to upgrade Palmer Road which runs from Chester Road to Brown Road, Nine tenths of a mile. By petition of Twenty-three registered voters. Gladys Baker was recognized for the purposes of a motion to accept the article as read. This was seconded by Bill Wildeman. Discussion was then opened on Article 19. Al Hall requested to move the question. This was seconded by Ingrid Byrd. The motion to move the question was passed. Article 19 was moved to a vote and DEFEATED.

**Article 21.** Shall we adopt the provisions of RSA 80:58-86 for a real estate tax lien procedure? These statutes provide that tax sales to private individuals for non-payment of

property taxes on real estate are replaced with a real estate tax lien procedure under which only a municipality or county where the property is located or the state may acquire a tax lien against land and buildings for unpaid taxes. By petition of fourteen registered voters. Mabel Brock made a motion to adopt the article as read, and it was seconded by Ingrid Byrd. Mrs. Brock was then recognized to speak to the article. A period of questions and answers followed. Mrs. Brock explained this article would give the Town more flexibility in handling individual cases. Don Belcourt asked to move the question, and this was seconded by Clay Caddy. The vote to move the question passes. Article 21 is a secret ballot vote. The results are as follows: 142 YES, 24 NO. Article 21 is ADOPTED.

**Article 22.** To see if the Town is in favor of a Three (3) year term for the Town Treasurer of Candia, term to begin in March 1989, pursuant to RSA 41:26-a. By petition of eleven (11) registered voters. Motion to accept the article as read was made by Chris Dupere and seconded by Don Coleman. Mrs. Dupere then spoke to the article for Town Treasurer Shirley Erving, who was in Florida. There was no further discussion, and Article 22 was voted on by secret ballot. 120 YES, 10 NO. Article 22 is ADOPTED.

**Article 23.** To see if the Town will vote to approve a change in the hours of operation of the incinerator from: Tuesdays and Thursdays from 12 noon to 8 P.M. and Saturdays from 8:30 A.M. to 4:30 P.M., to: Tuesdays and Thursdays from 2 P.M. to 8 P.M. and Saturdays from 8:30 A.M. to 4:30 P.M. and Sundays from 10 A.M. to 2 P.M. By petition of twelve registered voters. Motion to accept the article as read was made by Dean Young and seconded by Bruce Stevens. Janet Manter then wished to ammend the article to read: To see if the Town will vote to open the incinerator for at least four hours on Sundays. This was seconded by William Byrd. After a brief discussion, Diana Watts asked to move the question. This was seconded by Ernie Lefebvre. The vote to move the question passes. When the ammendment to Article 23 is put to a vote, it FAILS. Diana Watts then makes a motion to ammend the article to read as follows: To see if the Town will vote to approve a change in the hours of operation of the town dump from: Tuesdays and Thursdays from 12 noon to 8 P.M. and Saturdays from 8:30 A.M. to 4:30 P.M. to: Tuesdays and Thursdays from 2 P.M. to 8 P.M., Saturdays from 8:30 A.M. to 4:30 P.M., and Sundays for a period of four hours. This was seconded by Ernie Lefebvre. Following a brief discussion, a vote on the ammendment was taken, and passed. The ammended Article 23 was then voted upon and ADOPTED.

**Article 24.** To see if the Town will vote to authorize the Selectmen to apply for, accept and expend without further action by the Town Meeting, money from the State, Federal or other Governmental unit or a private source which becomes available during the fiscal year pursuant to RSA 31:95-b. Motion was made by Don Coleman and seconded by Don Belcourt to accept the article as read. There was no discussion, and when put to a vote, Article 24 was ADOPTED.

**Article 25.** To see if the Town will vote to authorize the Town to accept such funds as are made available to the Candia Forest Fire Warden, under the Rural Development

Act of 1972, Title IV. Motion was made by Don Coleman and seconded by Donald Seward to accept the article as read. There was no discussion, and when put to a vote, Article 25 was ADOPTED.

**Article 26.** To see if the Town will vote to authorize the Treasurer with the approval of the Selectmen to negotiate temporary loans in anticipation of taxes. Don Coleman made a motion to accept the article as read. This was seconded by Don Belcourt. There was no discussion, and when voted upon, Article 26 was ADOPTED.

**Article 27.** To see if the Town will vote to accept such trust funds as have been received this past year. Motion to accept the article as read was made by Don Coleman and seconded by Don Belcourt. There was no discussion, and when put to a vote, Article 27 was ADOPTED.

**Article 28.** To see if the Town will vote to authorize the Selectmen to administer or convey by auction or advertised sealed bids, any real estate acquired by the Town through Tax Collector's Deed. Pursuant to RSA 80:42. Motion was made by Don Coleman and seconded by John Thomson to accept the article as read. There was no discussion, and when put to a vote, the article was ADOPTED.

**Article 29.** To transact any other business that may legally come before said meeting. At this time, the traditional positions of Viewers of Fences and Scaler of Timber were selected. Bill and Claire Zarges were chosen by unanimous vote as Viewers of fences, and William Byrd was elected as Scaler of Timber. The motion to adjourn the meeting was made by Don Coleman and seconded by Les Cartier. The meeting was adjourned at 2:44 A.M.

## SELECTMEN'S REPORT

During 1988, the Town of Candia marked the 225th anniversary of Candia's incorporation in 1763. Our community is proud of its history, and is making steady progress toward long term solutions to the problems we face today.

After the most recent proposal to build a Town Office Building did not win the necessary support from voters at the 1988 Town Meeting, the Town Office Committee reorganized and continued to develop a plan that will be both adequate and cost-effective. We urge you to become informed and to support the new building plan at the next Town Meeting on March 18, 1989.

With the help of many volunteers to renovate and set up the premises, the Town Offices were moved from the small room at Henry W. Moore Elementary School and from the various official's homes, into a leased property at the corner of Route 27 and Business Loop 101. All of the town departments are able to work and keep records at one location convenient for residents to transact their business. This will enable the town officials to work more effectively, until a permanent Town Office Building is available.

The Selectmen's Office has continued the process of computerizing the town records and bookkeeping. This year we were able to add the Tax Collector's records and billings to the computer system.

Thanks to the outstanding dedication of Selectman Don Belcourt and the members of the Incinerator Committee, the Incinerator Site on New Boston Road has seen major improvements. The huge metal pile was removed, allowing us to clean and organize the area. Fencing was installed to better control the operation of the site. In addition, major steps have been started to recycle materials, with the goal of generating revenue to offset expenses to the town and extending the useful life of the incinerator.

We accepted with regret the resignation of Selectmen John Thomson in May of this year, due to health reasons. We would like to thank John for his enthusiasm and participation while he was a member of the Board. After an interview process involving several candidates, Mike McRae was appointed to fill the remainder of John's term.

The Candia Police Department responded to a steadily increasing number of calls this year. The police were able to move into new leased space in December, space equipped with both heat and plumbing. We would like to thank the members of the Candia Improvement Club for the use of their building in the interim. The Candia Police Department continues to enjoy an excellent mutual aid working relationship with neighboring towns.

Due to the decision of the voters at the 1988 Town Meeting to cut the proposed budget, we were unable to make proposed improvements to Candia's roads this year. However, the Highway Department was able to perform routine maintenance as required.



Candia resident Pattie Davis was recognized as Volunteer of the Year by the New Hampshire Municipal Association, for her work with the Candia Youth Athletic Association (C.Y.A.A.). We would like to congratulate her on her volunteer effort and her involvement with the children of Candia.

The Candia Youth Athletic Association and the Candia Boy Scouts were very active at Moore Park again this year, working cooperatively with the town. A new field house was built and the ball fields were leveled, loamed and seeded.

Once again this year, Candia enjoyed a traditional Old Home Day at Moore Park. Included in the festivities were a Five Mile Road Race, a One Mile Fun Run, concerts, a sneak preview of the Charmingfare Theater's fall production, clowns, hot air balloons, dunking booths (including soaked Selectmen), chicken barbeque, a softball game between the Police and Fire Departments, guided tours of historical sites in Candia, a nostalgic Sock Hop, a parade of classic cars and a fireworks display. We invite everyone to participate in Candia's next Old Home Day, which will be held on Saturday, September 16, 1989.

The Board of Selectmen appreciates the concern for our community that is demonstrated by the long hours of volunteerism and hard work by so many people. We welcome and encourage your ideas, your enthusiasm and your involvement in Candia's town government.

## Volunteer Fire Department

The Candia Volunteer Fire Department responded to 131 calls in 1988. These responses are broken down as follows: 38 vehicular accidents, 13 brush/grass fires, 12 vehicle fires, 12 chimney fires, 11 mutual aid calls, 6 assist the public calls, 6 fire alarm activities, 6 smoke investigations, 6 wire fires, 5 structure fires, 5 illegal burns, 3 boiler malfunctions, 2 false alarms, 1 bomb threat, 1 tire pile fire, 1 hazardous material incident, 1 good intent call, 1 dryer fire and 1 gas grill fire.

In 1988 the Candia Volunteer Fire Department completed outfitting our utility van. The van, designated as 50 Utility 1 or 50 U 1, has proven to be a most valuable piece of equipment which responds to all incidents for the fire department and is on special call for rescue and mutual aid emergencies.

The fire department has also drilled a new artesian well along with which we installed a new pump and associated plumbing. This well replaces the old dug well which had become questionable as to recovery and water quality in past years.

The Fire Department is proud to announce that five members have successfully completed classes for State of New Hampshire Certification of Career Level Fire Fighter qualification. This certification represents the third of four levels of Firefighters qualification in the State of New Hampshire.

The Candia Volunteer Fire Department is a 100% volunteer organization which depends upon the citizens of the Town through the tax base for our operating budget. Monies spent beyond this budget for additional equipment are raised through fund raisers put on by our members and through donations. As we are a non profit organization all donations made to the Candia Volunteer Fire Department are tax deductible. Donations to the department also come in the form of manpower, the hours which are usually long, in bad weather and in the middle of a sound sleep. There is no financial gratification, only the satisfaction of knowing you are serving your families and the citizens of the Town of Candia. We welcome anyone, who might be interested in becoming a member. Please contact any member of the department and we will see that you get an opportunity to fill out an application.

The Officers and Members of the Candia Volunteer Fire Department wish to express our sincerest thanks to the Candia Volunteer Firemen's Ladies Auxillary for their continuing support, again from all of us thank you very much.

The Officers and Members of the Candia Volunteer Fire Department also wish to express our grateful appreciation of the support shown us by the citizens of the Town of Candia in the past year. We look forward to your continued support and cooperation in the future.

## Candia Rescue

Candia Rescue continued to provide primary emergency medical care to victims of accident and illness in the town of Candia. We have continued to improve our effectiveness as providers of emergency medical services during 1988 and are pleased to report that we have been able to provide 24 hour per day coverage for the town. This was accomplished even though Candia Rescue is still a completely volunteer organization with only nine (9) emergency medical technicians and fire responders.

During 1988 we increased the level of care to the town of Candia with the addition of Advance Life Support (ALS) capabilities from both Candia Rescue and Derek's Ambulance Service. Several Candia Rescue members are scheduled for additional ALS training during 1989 which will broaden our capabilities even further. It should also be mentioned that the Candia Rescue members attend all training sessions on their own time and the only cost is for the actual course fees.

In 1988 Candia Rescue responded to 108 requests for medical assistance and provided treatment to 139 patients. Of these calls, 72 were for medical assists and 36 were responses to motor vehicle accidents.

1988 also saw the addition of Derek's Ambulance Service as the ambulance service for the town of Candia. Candia Rescue would like to report that the transition has gone very well. The addition of Derek's Ambulance Service has been one of the major factors in allowing Candia Rescue to provide ALS service to the town.

Candia Rescue would once again like to thank the towns people of Candia for their continued support. It is through your support that Candia Rescue can continue to provide emergency medical services to the town. We would also like to thank the Candia Volunteer Fire Department, Candia Police Department and Derek's Ambulance Service for their continued support during 1988.

## Police Report

I would like to make the following report of the activity of the Candia Police Department in the year 1988. We have experienced the same rate of growth in our caseload this year as we have had in the past several years. We have handled a total of 1513 cases this year, up from the 1310 cases we had last year. We have not completed some of the projects we had planned for 1988 as they had to be cut to stay in line with the budget cut the town voted at last Town Meeting. We hope to have the Juvenile Program in the Moore School this year we had planned to do last year. We cut the training budget this year which we will not be able to do next year as there have been changes in the training requirements set forth by the New Hampshire Police Standards & Training Council that make it necessary for every officer to have additional training each year to maintain his certification. This is an item we will have to address from now on because the law requires an officer to be certified to be able to work. We will continue to do everything we can to exhibit the high standards of professionalism expected of the police department.

# Candia Planning Board

## Review of 1988

### Personnel Changes:

In 1988, The Candia Planning Board witnessed the retirement of Roland Girard, past Chairman and Judith Szot who served as Chairman after Roland. Both of these individuals had served on the Planning Board several years, and we will miss this experience. We also regret that John Thompson, who had served as Selectmen's representative, was forced to retire due to health problems.

Mike McRae has taken over as Selectmen's representative and Diana Watts is now on the board. Sarah O'Neili recently joined the board as an alternate.

### Revisions and updates:

1988 has been a very active year at Town Meeting; 9 of 10 ordinance changes passed, including a new wetlands ordinance, a single family residential cluster ordinance and a number of other changes. Many of these are the result of many hours of "behind the scenes" effort by various current planning board members, and we commend them for their volunteer efforts. Candia's first Capital Improvements Plan was adopted in 1988 and the Subdivision Regulations were updated.

### New Lots:

In its review capacity, the Board received over 19 successful applications for subdivision, and as a result 46 new lots were approved. This compares to previous years as follows:

1988	46 lots
1987	19 lots
1986	30 lots
1985	20 lots
1984	23 lots

The big increase is partially due to heavy market pressure and partially due to several phased developments which were either continued or completed in 1988. It should be noted that several proposals (approximately 3 representing 9 potential lots), were denied. Approximately two boundary line adjustments were approved and three commercial site plans were approved.

## Outlook for 1989

### **Board Membership:**

The current Planning Board consist of William Thoden, Chairman, Lorraine Dufresne, Vice-Chairman, Ingrid Byrd, Boyd Chivers, Diana Watts and Mike McRae. Sarah O'Neill currently serves as an alternate. RSA 673 stipulates that the board can have seven (7) members and up to five (5) alternates. Thus, we have at least six (6) slots to fill. In addition, there are various openings for committee workers. With the recent resignation of Judy Lacombe, we are also searching for a Planning Board Assistant. There are many opportunities for those interested in shaping the future of Candia.

### **Anticipated Workload:**

Very recent trends observed in Candia and other nearby towns, coupled with business conditions/forecasts, strongly suggest that the development pressure will not be as great in 1989. The Board has therefore, reduced its official hearing nights to one per month (first Wednesday). This allows the Board to meet on the second Wednesday for committee work on the third Wednesday for a full worksession.

Several proposals are on the ballot for Town Meeting. We urge the citizens of Candia to study these proposals and come and cast your well informed vote on Tuesday, March 14, 1989. Following Town Meeting, the Board will begin work to update the town's Master Plan and review current zoning districts.

## **Incinerator Committee Report**

The past year has brought many changes to the incinerator facility, including a new name. We are now the "Candia Recycling Center" but will probably always be referred to as "the dump".

Our famous "old" scrap metal pile is gone. The entire site has been cleaned up and is now secured by a fence and a wider gate.

Our recycling programs are just beginning to show results. In the last few months of 1988 we realized over \$1,600 from the sale of recycled materials and the Candia Youth Athletic Assn. benefited from several months of redeeming aluminum cans for sports equipment.

We have a managed scrap metal area and a three year contract with New Hampshire Resource Recovery Assn. to remove and market it. We have a scrap metal attendant on duty Saturdays to help residents and to insure that the different metals are properly separated.

This year we hope to start glass bottle recycling which will probably require separating into clear, brown and green bottles and jars. Once started it will save the Town the cost of hauling about 125 tons to a landfill - more than \$10,000 last year. We are in the process of applying for a matching grant from New Hampshire the Beautiful to defray the start up costs of this program.

We developed and printed a pamphlet on rules for using the facility which is being distributed to residents. We also prepared a solid waste ordinance for the Selectmen to present to the voters at town meeting.

Our goals for 1989 are: to insure the proper maintenance and operation of the incinerator; to promote and improve existing recycling programs and to begin glass recycling; to look for more economical methods or means of solid waste disposal; to keep ourselves informed of all aspects of the solid waste problem; and, to keep you informed of our activities.

The committee, with two new members this past year, appreciate your patience as we have struggled to solve long-standing problems, your support of our efforts to improve your solid waste facility, and especially your cooperation in following the regulations necessary for the efficient operation of the incinerator and for the success of our recycling programs.

Our thanks to everyone who has helped us this past year; especially, Rick Desautels with the telephone, Mike Roy with dozer work and James Galgano with the rules pamphlet.

## **Proposed Candia Solid Waste Ordinance**

### **ARTICLE I: PURPOSE, AUTHORITY**

1. Purpose: The purpose of this ordinance is to provide regulations for the use of the Candia Recycling Center. In establishing these regulations, consideration was given as to the costs of labor and equipment, convenience to residents, available space, necessity to conform to state regulations, availability of a market for recyclable wastes, and procedures necessary to prolong the life of the incinerator.
2. Authority: These regulations are adopted under the authority of RSA 149-M:13,II and RSA 31:39.

### **ARTICLE II: GENERAL PROVISIONS**

1. The Candia incinerator site shall be known as "The Candia Recycling Center", hereafter referred to as "the Center".
2. The Center shall provide for the disposal of all solid wastes, except septage, produced in Candia by residential, commercial and industrial sources.
3. The Center shall function as an incineration and recycling facility. All salvage rights and receipts belong to the town.
4. The Center shall be closed on Thanksgiving, Christmas, New Year's Day, 4th of July, Memorial Day, Labor Day, and Easter.
5. The Board of Selectmen shall set the hours and days of operation of the Center, which shall include Sunday operation.
6. The Board of Selectmen shall establish procedures for the collection of fees, charges, and fines.

7. Residents and non-resident property owners shall be issued permit stickers, at no charge, for use of the facility according to procedures established by the Board of Selectmen. All permits must be attached to a motor vehicle and be plainly visible. Any attendant at the Center has the authority to refuse use of the facility to anyone without a valid sticker unless prior approval has been obtained from a Selectman.
8. Dump picking is not allowed without permission of an incinerator attendant. Compensation to the town is expected for items of value, the amount to be determined by the attendant in charge.

### **ARTICLE III: USE REGULATIONS**

1. The Board of Selectmen shall establish regulations for the use of the facility so that the Center can function in an orderly and efficient manner.
2. Recycling of the following materials is mandatory if or when a program for marketing them exists at the Center. Changes may occur due to market fluctuations.
  1. Aluminum beverage cans.
  2. Scrap metals.
  3. Clear, green and brown glass bottles.
  4. Newspaper and cardboard.
  5. Plastics.
3. To prevent damage to the incinerator and/or to avoid unnecessary costs, the following items shall not be incinerated:
  1. Glass, ceramics, pottery, china, and like materials.
  2. Most other unburnable wastes, including metals and construction materials.
4. The open burning area is for brush, slash, tree cuttings less than 5" in diameter and unpainted or untreated wood. No stumps or tree cuttings over 5" in diameter can be accepted.
5. No hazardous or toxic waste as defined in RSA 147-A:2 can be accepted.
6. No sludge or septic waste can be accepted.
7. Dead animals may be incinerated by special arrangement. There will be a cost to non-residents of \$7 per cat and \$12 per dog. Fees for other animals will be determined by the Selectman in charge of the Center.
8. Commercial haulers, defined as anyone who hauls materials to the Center for others for a fee, cannot use the Center unless:

1. The material was collected within the limits of Candia
  2. The material is separated and disposed of following these regulations.
9. Industrial wastes, defined as any waste from any process or industry, manufacturing, trade, or business, located in Candia will be accepted if in conformity to these regulations, unless its disposal will require special handling or undue cost to the town as determined by the Selectman in charge of the Center.
10. Confidential papers may be incinerated by special arrangement.

#### **ARTICLE IV: VIOLATIONS AND FINES**

1. Violations: The following shall be considered violations of this ordinance:
  1. Failure to comply with the provisions of this ordinance.
  2. Failure to obey directions from the attendants.
  3. Failure to have a valid sticker permit.
  4. Failure to dispose of material in the proper location.
  5. Entry into the Center when the gate is locked.
2. Fines: Any person or corporation in violation of this ordinance may be fined up to \$1,000 for each violation and/or \$5 per cubic yard of waste, whichever is deemed most appropriate by the Selectmen in charge of the Center, said fines to be used to promote and expand the recycling program of the Center.

#### **ARTICLE V: LEGAL**

1. Enforcement: The Selectman in charge of the Center shall enforce the provisions of this ordinance and set the amount of fine to be assessed for violations.
2. Separability: The invalidity of any provision of this ordinance shall not affect the validity of any other provisions herein nor the validity of the ordinance as a whole.
3. Repealer: Passage of this ordinance shall automatically repeal and other existing ordinance relating to the incinerator, the site, or its use.
4. Amendments: This ordinance may be amended at any town meeting by majority vote.
5. Effective Date: This ordinance shall take effect upon its passage.

## **Report of the Southern New Hampshire Planning Commission**

The Southern New Hampshire Planning Commission offers a wide variety of services, resources and technical assistance to all towns that are dues-paying members of the Commission. A professional planning staff, assisted by consultants in certain specialized fields for which the Commission is unable to employ a full-time staff, work, under the direction of your representatives to the Commission in developing and carrying out planning programs that require regional perspective as well as which pertain to your community.

Local planning assistance requests are normally made by the Planning Board and/or the Board of Selectmen of your town based on your local priorities. However, certain general studies, notifications or acquisition of resources that are deemed essential for all member municipalities of the Commission are also conducted with the concurrence of the Commission.

Services that were performed for the Town of Candia during the past year are as follows:

1. Provided testimonies to the House and Senate committees of the 1988 session of the General Court on the HB 899, 928, 1045, 1104, 1069, and 1072; and SB 338 and 326. These bills pertain to planning and zoning issues which were relevant for the municipalities;
2. Co-sponsored the Municipal Law Lecture Series, to which Candia officials were invited;
3. Provided technical assistance to the Planning Board on the procedure for handling excavation permit applications and site plan review procedures;
4. Provided technical assistance to the Planning Board on the provision of including the fire code in the site plan review regulations;
5. Provided a sample ordinance for dealing with fire protection provisions in a large building; and
6. Provided the Planning Board with a suspended warrant article authorizing the Planning Board to conduct site plan review of changes or expansion of use.

## **Report on Conservation Commission**

Yes the Commission has been active now for 16 years. During that time, we have under management, a 40 acre Conservation lot on New Boston Road. On it are Wet Lands, some timber and a freely flowing brook. We also have a prime wet land and part of Kinnicum Pond, the only natural Pond in Candia. On Flint Road we have established a Town Forest. During the Oil Shortage, wood from this land was cut for the Town needy.

Scenic roads have been designated and Wet Lands located and mapped. The Commission has also been responsible for site inspection on Dredge and Fill applications.

Recently new members have been added to the Commission and a more active role is anticipated in acquiring more Wet Lands for the Town, to help conserve Ground Water. The land all around Kinnicum Pond should be acquired or be put under Conservation Easements. There is also the possibility, that the old Allenstown Candia Rail Road Bed may be available, if the Commission can get the people of Candia to help acquire it. This would give a right of way to the land we own on Kinnicum Pond and all along the Moose Meadow Brook and Wet Lands.

**VNA Home Health Services, Inc.** is Medicare and Medicaid certified provides skilled nursing care; physical, occupational and speech therapies; nutrition counseling and medical social services; certified home health aides; Hospice care for the terminally ill; and long term care for the elderly and the handicapped. Medical equipment, such as beds and wheelchairs, is also available. Payment for service includes health insurances, and private payment. Fees are explained to our patients at the first visit to the home and for those unable to pay the usual fees, adjustments can be made on an individual basis.

**VNA Community Services, Inc.** provides free Immunization Clinics for all age groups monthly and Free Blood Pressure screening clinics. Watch your local paper for date and place. Foot Care Clinics are held monthly at our 194 Concord Street office by appointment and blood pressure checks are done weekdays from 1:30 - 4:00 p.m. Occupational Health programs are provided to business and industries on site. Parent-Child Health Services include Teenage Pregnancy Program, and the Parent-Baby (ad) Venture Program for children at risk of abuse and neglect, The Body Shop-Teen Weight Control Program, and the Child Care Connection for child care providers.

**VNA Personal Service, Inc.** provides private duty nurses, home health aides, homemakers, companions, personal care assistants and child care in the home.

## Lamprey Health Care

Lamprey Health Care marks eighteen years of service in 1989!

Two medical offices, one in Newmarket and one in Raymond, provide primary medical care, preventive health services, community outreach, social services and short term counselling with referral to mental health agencies.

Services also provided by Lamprey Health Care consists of six physicians: Sarah C. Oxnard, MD is a Pediatrician and is the Medical Director of Lamprey Health Care. Edward G. Benoit, MD is a Family Physician and is Associate Medical Director at our Raymond facility. Karen O. Brainard, MD is a Family Physician practicing in raymond. Paul E. Friedrichs, MD and Micki A. Kantrowitz, MD are both Family Physicians at the Newmarket Center. Cynthia A. Rasmussen, MD is an Obstetrician/Gynecologist who directs the Prenatal Program operated by Lamprey Health Care and provides gynecological services. Also on staff at Lamprey Health Care are Michael C. Lewis, Certified Physician's Assistant, Barbara Janeway, Nurse Practitioner and John Mark Blowen, Nurse Practitioner. Registered and Licensed Practical Nurses and a Medical Assistant round out the medical team.

The addition of physicians in recent years has allowed Lamprey Health Care to respond to the growing demand for services in this area.

Lamprey Health Care continues to operate the Senior Citizen Transportation Program. The transportation service enables seniors citizens to remain independent, self-sufficient and active by providing a means to needed services such as food shopping, pharmacy, meals, medical appointments and recreational trips. Three of the busses are equipped with hydraulic lifts to provide services to individuals in wheelchairs.

Lamprey Health Care also operates the Rockingham County Info-Center which provides information and referral services to the residents of the area. Information and referral is available to callers through a toll-free number on a wide range of subjects. The toll-free number is 1-800-582-7214.

## **Rockingham County Community Action Program, Inc.**

Rockingham County Community Action Program, Inc. (RCCAP) is a private, non-profit corporation, officially designated as the anti-poverty agency to serve the low-income population of Rockingham County. Our mission is to serve the multitude of needs of the county's low-income residents by assisting them in coping with the hardships of poverty, giving them the tools to lift themselves out of poverty and seeking to eradicate the root causes of poverty. RCCAP has been effectively serving these needs for more than twenty-three years.

As a county-wide organization linked to state and national service networks, we at Community Action seek to mobilize all available resources, both private and public, to bring to bear on the problems of poverty. As an agent of change, we encourage low-income individuals to attain the skills, knowledge and motivation to become self-sufficient. As advocates for the poor, we strive to create a general community awareness of and responsiveness to the needs of the disadvantaged.

The Greater Raymond Community Action Center is the outreach center serving residents of Candia and 14 other communities, and as such acts as Candia's central resource for information regarding all available human services. In addition, RCCAP offers 18 other service sites for the application and provision of various Community Action services.

Of the major direct service programs offered by Community Action, the following were provided to eligible residents of Candia:

44 households received Fuel Assistance, a program which provides a financial grant of up to \$500.00 to assist with energy-related expenses.

4 homes were weatherized through the Weatherization Program, which provides high quality materials and trained labor to weatherize homes in order to reduce heating costs and conserve energy.

2 households received the Supplemental Energy Program, which provides for the repair or replacement of furnaces and heating units and home repairs for low-income homeowners.

5 children were provided meals from private family day care homes which participate in the Rockingham Family Day Care Program.

1 child care referral was arranged through the Child Care Resource and Referral Program, which compiles current data on all available child care options, provides child care referrals to employees of participating companies as well as to the general public, and expands the supply of quality day care by recruiting, training and assisting new day care providers.

1 child was enrolled in Head Start, a comprehensive, early childhood development program for low-income and handicapped children and their families.

19 women, infants and children received help through the WIC Program, which offers supplemental nutritious food and nutrition counseling to pregnant women, nursing mothers and children up to the age of 5 who are nutritionally at risk.

2 households received Crisis Assistance, a program which provided a one-time financial grant for the payment of rent, mortgage, electricity or fuel for those in emergency situations.

130 food packets were provided through the Surplus Food Program, which distributes USDA surplus cheese, butter, flour, dry milk, cornmeal and rice through mass distributions.

2 households received emergency food packets through the Emergency Food Pantry, a program which provides a temporary supply of non-perishable food to families in crisis.

In addition to these major programs, much of our staff time is devoted to working with people who come to us seeking help. During the past year, we received 164 calls or visits from Candia residents, many of which were crisis calls involving fuel or utility problems, the lack of food or clothing or general financial needs. By working closely together with local and state welfare administrators, fuel and utility companies, other human service agencies and interested clergy and civic groups, we are able to link those in need with the services available to them.

Since the services we offer greatly relieve the towns we serve from the full burden of providing for the needs of their low-income residents, we ask every community we serve to make a financial contribution to our agency based upon the level of service we have provided to its residents. The amount we request equals 3.5% of the total dollar value of services provided during the previous fiscal year, which means that we request \$3.50 for every \$100.00 we provide in direct services.

From July 1, 1987 through June 30, 1988, Community Action provided \$50,221.00 in services to Candia residents. We are therefore requesting the town of Candia to contribute 3.5% of this amount, or \$1,758.00. The town of Candia has contributed to our agency for many years, and we extend our appreciation to you for your continued support.

## **Rockingham Counseling Center** **(Formerly Rockingham Child and Family Services)**

During the past year we experienced many changes. As you may notice from our letterhead, we changed our name from Rockingham Child and Family Services to Rockingham Counseling Center. We feel that our new name more accurately reflects our commitment to provide counseling to **all** individuals who may be experiencing difficulties. Additionally, our kind and generous landlord of several years, Phillips Academy, was unable to renew our lease. This necessitated our move to a new location at 9 Hampton Road, Exeter. We also expanded our service; with an office in the "Hospital Hill" complex in Portsmouth and a satellite office in Raymond.

What has not changed, is our commitment to provide counseling services to all individuals experiencing problems such as drug and alcohol abuse, divorce, depression, child abuse, etc. In the past year we provided over 2,700 hours of counseling to those in need of help. One of the reasons our clients come to us, is due to their inability to pay the hourly fees of \$50.00 to \$75.00 per hour. We provide individual and group counseling regardless of their ability to pay. We evaluate each client's financial capacity and adjust billings on a sliding scale basis.

As you can see from the enclosed copy of our 1988-89 budget, sources of revenue include; The Seacoast United Way, patient fees, charitable contributions, fund raising events and the support of the State, County and the various towns of Rockingham County. The town contributions are a primary source of funding, representing approximately 30% of our operating budget.

We hope that the Town of Candia will look favorably on our request of \$650.00. Your contribution will serve to maintain the Rockingham Counseling Center as a social service for your community. ## **Rockingham County Nutrition Program**

Primarily we are a nutrition service, serving homebound and congregate noon meals to the handicapped and elderly. Our service provides: hot, nutritious noon meals which meet the 1/3 of the daily caloric and nutritional guidelines as prescribed by the federal government, weekend meals for the homebound who need them, night meals for the homebound and holiday meals (canned or frozen) and blizzard bags (meals that are shelf stable and can be used when meals service is interrupted due to inclement weather).

Other services we provide are: support counseling, referral and information, transportation and outreach. All of these factors are very important as they help us link the client with the outside community and this helps the client live in the least restrictive environment without compromising his/her safety.

Specifically in your towns we have served 17 congregate clients and 34 homedelivered clients. The site is located at St. Paul's Catholic Church on Main St. in Candia. Many activities take place at the site and the seniors can come and socialize along with sharing a delicious meal together. Last year the Candia site provided 14,978 meals.

## Vital Records

Dear Citizens of Candia:

I am including the following information as a preface to the pages regarding the Vital Records for the past year in the Town of Candia. This is an attempt to clarify the confusion regarding the duties of the Town Clerk when recording and reporting Vital Records, (births, marriages, and deaths), for the Town Report. According to the Bureau of Vital Records of the State of New Hampshire, the Town Clerk is required to record only those which actually occur in his or her town.

For example, if a resident or non-resident dies in the Town of Candia, I must record that death, issue copies of the death certificate, and send a copy of the certificate to the State. However, if the person, even if he or she has been a life-long resident of Candia, dies in another town, then it is the responsibility of the clerk of that town to send me an informational copy of that death for my records, but she is the only person that may issue certified copies in that instance.

Many times, if the death occurs outside the Town of Candia, the clerk in the town of occurrence will send me that informational copy for my records. There are times, however, when this does not occur, and unless I am informed by a family member or another person who has knowledge of that death, I am unaware of it and the name will not appear in the Town Report. It is especially difficult to receive death reports when the person has died out of state.

I hope this information may help you better understand the situation, and I apologize if I have omitted someone in this year's Vital Records for the Town Report. If an omission has occurred, please contact me, and I will make certain that the information is included in next year's report.

Mr. Claver discussed the survey which had been passed out earlier this school year, pointing out the results of the survey from the Long Range Planning Committee. This community response survey will be used by the committee in developing an over all plan for the next ten to thirteen years, which will be presented to the School Board at the May 1988 meeting. The Board will then review the report, and adopt it or send it back for revision or whatever is appropriate. The Report will then be made public. There was no further discussion on Article 1, and when moved to a vote, the article was adopted.

**Article 2.** To see if the District will vote to authorize the School Board to apply for, accept and expend, without further action by the School District Meeting, money from the State, Federal or other Governmental unit or a private source which becomes available during the 1988-89 school fiscal year provided that such expenditure be made for purposes for which a school district may appropriate money and that such expenditure not require the expenditure of other school district funds. Further, that the School Board hold a public hearing prior to accepting and spending such money. Motion was made by Joan Tancrede, "I move that the District vote to authorize the School Board to apply for, accept and expend, without further action from the School District Meeting, money from the State, Federal, or other government unit or a private source which becomes available during the 1988-89 school fiscal year, provided that such expenditure be made for purposes for which a school district may appropriate money and that such expenditure not require the expenditure of other school district funds. Further, that the School Board hold a public hearing prior to accepting and spending such money." Motion was seconded by Mr. Maloney. Mrs. Tancrede was then recognized to speak to the article. There was no discussion on the article, and when moved to a vote, Article 2 was adopted.

**Article 3.** To see if the District will vote to raise and appropriate the sum of Eight Hundred Fifty-nine Thousand Three Hundred Nine and 00/100 (\$859,309.00) Dollars to fund all cost items relating to teacher's salaries and benefits for the 1988-89 school year. One Hundred Eight Thousand Thirty Eight and 00/100 (\$108,038.00) Dollars of such sum



representing additional salaries and benefits attributable to the increase in salaries and benefits over those obligations payable under the previous year of the Collective Bargaining Agreement entered into by the School Board and the Candia Federation of Teachers. (This is the third year of a three-year contract.) Robert Claver was recognized for the purposes of a motion: "I move that the District raise and appropriate the sum of \$859,309.00 to fund all cost items relating to teacher salaries and benefits for the 1988-89 school year; \$108,038.00 of such sum representing additional salaries and benefits attributable to the increase in salaries and benefits over those obligations payable under the previous year of the collective bargaining agreement, this being the third year of a three-year contract." Motion was seconded by Joan Tancrede. Mr. Claver was then recognized to speak to the article. There was no discussion, and when moved to a vote, Article 3 was adopted.

**Article 4.** To see what sum of money the District will vote to raise and appropriate for the support of schools, for the payment of salaries and benefits for school district officials and agents other than benefits and salaries payable to teachers and for the payment of the statutory obligations of the District. Richard Robidoux was recognized for the purposes of a motion. "I move that the District raise and appropriate Two Million Two Hundred Three Thousand Four Hundred Fifty-eight Dollars and 00/100 (\$2,203,458.00) for the support of schools, for the payment of salaries and benefits for school district officials and agents other than benefits and salaries payable to teachers, and for the payment of the statutory obligations of the District." The motion was seconded by Mr. Claver. Mr. Robidoux then spoke to the article. After a lengthy discussion period, Article 4 was moved to a vote, and accepted.

Motion to adjourn the meeting was made by Richard Robidoux, and seconded by Roger Leavitt. The meeting was adjourned at 8:50 P.M.

# **Candia School Board Report**

## **1987/1988 School Year**

With the completion of the 1987/1988 school year, the Candia School Board looks back with pride at the achievements of the Candia Moore school as it continues to improve the quality of education and maintains a watchful eye on the ever-increasing price of services. The Board continues to manage the growth in school population, the demand for services, the need for more space, the increase use of the school by town activities and the town's ability to fund these expenditures by careful planning and tight budgetary control. The board sincerely appreciates the town's support of the school and the School Board.

During the summer, the Board oversaw the completion of the expanded ball field and the rehabilitation of the outside basketball court. The landscaping was completed along with the installation of a perimeter fence. This project doubled the previous facilities and provided two ball fields for school and town use.

The Moore School welcomed Mr. Andy Bilodeau as the new full-time assistant principal and Mary Anne Byrne as the new Special Education coordinator. Their dedication and professional manner have contributed greatly to the ever-increasing demands on the administration of the school. Their efforts are sincerely appreciated. Several new teachers were hired and have become valuable members of our staff. Our appreciation is extended to the new staff for their effective transition into our school and to the veteran staff for providing the support necessary.

The Long Range Educational Planning Task Force continued to examine the educational needs in our town and to sample the town's attitudes toward education in Candia. The Committee commissioned an attitude questionnaire and is incorporating the results into the long range plan it is preparing. Along with a continuing preschool census, this plan for education in Candia will help outside the school in making informed decisions about its future. The School population stood at 480 in October of '87 compared to 473 in October of '86. This planning will continue for the rational, effective, efficient, and economical response to the pressure of growth. More citizen input will be required this year to outline the future of our school.

Increased demand for the use of school facilities was one of the many issues dealt with by the board's policy development committee. A new procedure was adopted with more direct contact with representatives of the user groups.

The California Achievement Test was made part of the accountability plan as it is the testing being recommended by the department of education in NH. This will allow Candia to be compared to other schools in the state as well as nationwide.

In January 1988, the board signed a new three-year contract with Central High School and with Raymond High School. Candia high school students will have the option to elect

Central High School or Raymond High School.

In June, the board made its first yearly award of the **Candia Grange Scholarship**. The scholarship, made possible by a generous gift from the Candia Grange, is awarded to Candia high school students planning to further their education. The Board wishes to extend its gratitude to the Candia Grange for the funds. This years recipients were: Shannon Lavery (UNH) and Nguyen Tran Vinh (Northeastern University). All high school seniors are encouraged to apply. The board would like to state that any donations to increase the principal of this fund will be greatly appreciated.

The Board takes pride in the positive gains in the quality of education. We appreciate the dedicated efforts of our administrators and our professional and support staff. We are encouraged by the achievements of the students, applaud the parents and the town for their continued support, and look forward to another successful year as we meet the challenges of 1989.

Increasing our educational accountability through the use of acheivement testing in grades 2-8. Student achievement continues to be equal to and above state average at each grade level.

The renewed commitment to work towards the hiring and maintaining of a highly qualified staff. Transfers, non-renewals and new positions aside, we experienced a rate of only 5% teacher turnover.

The steady and extensive work of the Long Range Planning Task Force in the development of a planning resource document to aid in the future development of the Candia School System.

The implementation of a new Health curriculum through which we have worked to address many of today’s issues while preserving the opportunity for your input.

The continued operation of a safe bus transportation program “getting kids to and from school safely,” in which run schedules were maintained and we were able to accomodate parents requests.

The ongoing efforts to maintain our building & grounds despite year-round day and evening use. As an example, during the winter months an average of 19 evening events were held each week. These included public meetings, dances, basketball games, etc., all held in addition to the regular school day and extracurriculum student activities. You are getting full use of your school facilities.

The initial revision of the school Language Arts curriculum with an emphasis on students writing and related skills.

And, the continued and necessary work on all of our parts to make the Henry W. Moore School the kind of school that still has concerts, plays, academic competitions, field days and all of those special activities that can make a difference in children’s lives.

During the 1988-89 school year we are faced with the challenges of further growth, the need to continue work to promote student’s motivation and learning, a new and important teacher’s contract, the continued upkeep and improvement in our facilities and the need

to make the most of a shrinking dollar. I feel that working together we can meet these challenges.

I wish to recognize and thank David Cawley the Superintendent of Schools and his staff, the Candia School Board, the school staff and you, for your continued support and interest in the quality of education in Candia.

## **Superintendent of Schools Report**

In my report last year I did indicate because of the new five room classroom addition it would only provide relief for the increased enrollment at the school. Where we are now in the 1988-89 school year it becomes imperative that we again look at this increased enrollment along with programming and size.

Mrs. Betty Thomson, school secretary, retired from her position as of June 30, 1988. The Candia School District is very grateful to Mrs. Thomson for her many years of dedicated services to the community, especially for the benefit of the youth.

The turnover in staff was quite high last year. A great deal of time was spent on recruitment of teachers inasmuch as more than 15 to 20 staff members left their positions.

Stephen Russell has completed his second year as Principal of the Candia Moore School, and has assumed an excellent leadership role in his position there.

The district recently entered into a three year contract with the Manchester School System for the tuition of Candia high school students.

The Candia School District provided special education services to 68 students during the 1987-88 school year, representing a 5% increase in educationally handicapped students served the previous year. The district was able to employ a qualified speech/language therapist greatly enhancing the provision of services. District personnel carefully studied the range of special education services offered to determine if there were unmet needs. As part of the P.L. 94-142 project an extensive review of high school students' records was conducted to find students age 16 to 21 years who might have a need for special education services. Also a Child Check Clinic was conducted to screen potentially handicapped children aged birth to three years.

On April 8, 1987, the New Hampshire State Board of Education adopted revised minimum standards for all public elementary schools in New Hampshire. It is the intent of the State Board of Education that all standards be met by June 30, 1991.

Each school must develop a school implementation calendar that will establish priorities for each school year. This calendar will be used by the State Board as the time-line for compliance with the revised minimum standards. We have begun the process to meet the new State requirements.

I appreciate the support and cooperation I have received from the Candia School Board members, administration and all staff at the Candia Moore School, and the citizens of the community throughout the past year.

# **Burning Regulations**

## **State of New Hampshire**

### **IN CASE OF FIRE .....Phone 483-2311**

Written permits must be obtained from the Forest Fire Warden for all open fires at all times, when the ground is not completely covered with snow.

Permits will not be issued for the kindling of open fires between the hours of 9:00 A.M. and 5:00 P.M., unless raining and the Forest Fire Warden is notified and grants permission to burn in the rain.

Permits for grass, brush, campfires, etc., must be obtained on the day the burning is to be done.

Permits for screened incinerators and properly constructed outdoor fireplaces may be obtained for the season.

There is no charge for permits which may be obtained from the Candia Forest Fire Warden or a Deputy Forest Fire Warden. Permits may be obtained between the hours of 3:00 P.M. and 7:00 P.M. on the day the burning is to be done.

All fires seen and reported by the fire lookout tower are checked with these permits and any person found to be burning without first obtaining a permit are subject to a fine up to \$200.00

Any person found to be burning after being refused a permit because of unsuitable weather is subject to a fine up to \$500.00

These regulations are set up by the State of New Hampshire Forestry and Recreation Department and the Town of Candia Forest Fire Department.
