41 bales = **47,719** lbs. = **23.86** tons

One glass haul = **20,400** lbs. **= 10.20** tons

One electronics haul = 5690 lbs. = 2.85 tons

The **23.86** tons of baled recyclables plus the **10.20** tons of glass and the **2.85** tons of electronics gives us a grand total of **36.91** tons recycled during December 2011.

On 12/1 there was **16.38** tons of mix paper marketed which generated **\$655.20** in revenue, while the **8.19** tons of cardboard generated **\$737.10**; for a total of **\$1392.30**.

On 12/2 we delivered a load of non ferrous materials which generated \$1929.40 in revenue.

On 12/21 there was **2626** lbs. of #2 natural plastics marketed which generated **\$722.15** in revenue.

For the month of December 2011 the CRC generated \$4043.85 in revenue.

For the year 2011 the CRC set a new revenue record with **§70,866.59** generated from recycling.

January 2012

Subject: Parks, Other Culture & Recreation Monthly Report

Moore Park

The park is resting for the winter. The water to the Doucette Fieldhouse was shut off and the lines blown out in early December. Hopefully that will eliminate the annual exercise in repairing the plumbing. The electric meters in the park have been identified and the charges should be showing up on the P&R expenditure reports now, based on the changes to the budget done in September. Several new covered trash barrels were purchased for the pavilion before the end of last year and I'm planning on rearranging the locations of the recycling/trash containers to get the trash containers on the ends of the pavilion, rather than in the centers. Looking back on the last three years, it's clear that Moore Park is a significant benefit to the town, that it can maintained inexpensively if we can manage to nurture and grow the numbers of volunteers and that there are a whole host of currently unmet needs to maintain it and unlimited opportunities to improve it. I'm working on it.

Lights on the Hill used the parking lot for overflow parking for their event in December and I haven't heard any complaints.

A representative from the LGC/Primex met with me to review the playground equipment and provided me with a copy of a 2008 report that LGC/Primex had done on the Park. We spent a couple hours on a very cold early winter morning going over the equipment and the report. He was very helpful and it was evident that some of the concerns raised in the earlier report had actually been addressed. It would have been helpful if the report had been available three years ago.

Moore Park Playground

Playground equipment repairs are in-process, with \$3000 encumbered to cover them. With the open winter so far this year it seems that the playground remains constantly busy.

Skateboard Park

Repairs of the newly donated equipment structures were completed by a local contractor, securely fastening the transition plates to their concrete bases. Hopefully this will cure the problem. Only time and use will tell. We'll continue to monitor it this summer.

Summer Recreation & Winter Ski Program

The 2012 winter ski program has successfully wrapped up. Administration was again capably handled by the CYAA. Final numbers aren't in yet, but for both program's bus transportation it looks like the town's costs will be around \$250. CYAA has been handling the bus payments directly for the last two years, eliminating town expenditures (and revenue) so I've had discussions with them about establishing a contract next year that would reduce the appropriation for the program to our actual historical costs.
