Reference: the revolving detail account

I would like to raise the amount of the officer portion of the special detail rate from the current \$35.00 hour to \$40.00 an hour. I have attached a list of detail rates from several Agencies as a comparison. Only one other town on the list is at our special detail rate and that is Nottingham. Most communities have a higher rate. Some of the Agencies such as the Auburn Police fill our details when there is no Candia officer available. The Auburn Police bill the entity \$57.00 an hour and the officer receives \$40.00 an hour. Our rate hasn't been changed in several years. In addition, I feel that the billing rate for the detail should be increased to \$60.00 from the current \$50.00 per hour to cover the cost of the cruiser as well as other costs such as retirement, FICA, fuel, maintenance, etc. In working with Donna Becker a spread sheet of costs associated with the details was generated (see attached). It costs approximately 0.64 an hour to operate a cruiser based on 2014 expenditures. I think it makes senses to have this amount pulled from the revolving detail account (just like the retirement costs) and credited towards the general fund.

After these expenses are paid any remaining funds in the revolving detail account would be used to offset any equipment purchase(s) or towards the payment for a cruiser. Recently the Selectmen authorized the expenditure of up to 8,000.00 for equipment for the new police vehicle, so it would be a prudent idea to generate revenue for this account and reduce raising and appropriating tax funds.
