Furthermore, in accordance with the requirements of RSA 72:23, I(b), the licensee(s) and any other entity using and/or occupying property of the town, pursuant to this license shall be obligated to pay real property taxes on structures or improvements added by the licensee(s) or any other entity using or occupying property of the town, pursuant to this license.

The license granted herein, and the duty to pay properly assessed real and personal property taxes, shall apply to any other entity, now or hereafter, using or occupying municipal property pursuant to this license. The duty to pay properly assessed real and personal property taxes shall apply both to the owner and joint owner of any such pole or conduit, or an attacher to or user of said pole or conduit, pursuant to permission or by agreement of the owner of said pole or conduit. Within 90 days of the adoption of this amendment, the licensee(s) and any other users, occupying or using municipal property pursuant to this license, shall be responsible for notifying the Clerk of the Town of Candia as to the use of the poles and conduits hereby licensed. Such notification shall include the following information: the identification number and location of all poles and conduits being used or occupied by any additional parties other than the named licensee; the property and equipment attached; and, the name and address of each such party using, attaching to, or occupying said poles or conduits.

As a condition of this license, the licensee shall, on an annual basis, beginning on April 1, 2016, provide the Clerk of the Town of Candia with a complete list of

each entity attaching to, or using any pole or conduit licensed hereunder. Said list shall be updated annually and shall include the following information: the identification number and location of all poles and conduits being used or occupied by any additional parties other than the named licensee; the property and equipment attached; and, the name and address of each such party using, attaching to, or occupying said poles or conduits. In the event that attachments and/or equipment is removed during the course of the year, written notification, containing the specifics thereof, shall be provided to the Town Clerk.

Dear Board of Selectmen:

The undersigned is legal counsel to Public Service Company of New Hampshire, d/b/a Eversource Energy ("Eversource"). Eversource has received your notice of a public hearing at which the Town of Candia will take up the matter of a petition by the assessor for the Town of Candia for the universal amendment of existing pole and conduit licenses in the Town, to require the payment of properly assessed property taxes, and to require licensees to provide information pertaining to entities attached to their poles or conduits.

This is to advise that, to the extent the proposed amendments seek to make language changes to the pole licenses of Eversource consistent with RSA 72:23, and the rulings of the New Hampshire Supreme Court in N.E. Tel. & Tel. Co. v. City of Rochester, 144 N.H. 118 (1999) and Verizon New England v. City of Rochester, 151 N.H. 263 (2004), Eversource does not intend to raise a legal objection to the amendments. However, this should not be construed as a waiver of Eversource's rights to protest, seek an abatement of, or otherwise legally challenge as excessive or disproportionate the assessment by the Town of Candia of any incremental property tax upon Eversource's use or occupancy of the public right of ways in Candia, and Eversource fully reserves all such rights.

Eversource does, however, object to the proposed amendments to include the requirement or condition that the licensee (1) notify within 90 days of the date of amendment each attacher to the licensee's poles or conduit, by serving a copy of the petition on each attacher, (2) submit to the Town Clerk a complete list of attachers to each pole or conduit, listing the pole or conduit locations of each, and (3) update annually on or before April 1st the information provided to the Town Clerk, including the location of additional attachers, and any attachers that have removed or added new attachments.

These conditions are not revisions required under RSA 72:23, or the New Hampshire Supreme Court cases interpreting that statute, in order to legally assess and tax either the facilities or equipment of the named licensee, or the use and occupancy of the public right of way by the named licensee. Furthermore, such other attachers, to the extent they may exist, are required to license or permit their facilities located within the public rights of way with the Town of Candia pursuant to RSA 231:159, et seq., just as Eversource is. Consequently, the identity of attachers utilizing the public rights of way, whether by attachment to existing utility poles, conduit or otherwise, should be obtainable from Candia's own public highway licensing records. Eversource is not aware of any statute or other provision of law in New Hampshire which authorizes the Town of Candia to compel Eversource to provide this information as a condition of a pole or conduit license.

We also bring to your attention that, in accordance with the requirements of RSA 374:34-a, public utilities such as Eversource must provide non-discriminatory access to their distribution poles and conduit to certain third parties seeking to use them for attachment of their own lines, cables and appurtenances. Under existing regulations of the New Hampshire Public Utilities Commission (Puc 1303.08), such third parties are required to clearly label their attachments with owner identification. This affords another means by which the Town may obtain its own information pertaining to attachers utilizing the public rights of way.

Under the above circumstances, Eversource maintains it is neither legally necessary, nor fair or reasonable, to require a licensee to provide or report to the Town information about others using the licensee's poles or conduits licensed in the public right of way. Such a license amendment is not required in the public good.

As Eversource is unable to send a representative to your hearing, Eversource respectfully requests that this letter be included in and made a part of the record of the minutes of the hearing of this matter on April 11, 2016. Thank you.

The Candia Recycling Center land filled 63.85 tons of municipal solid waste (MSW) during March 2016. The Center disposed of 40.47 tons of C & D debris during March 2016. The Center processed 104.32 tons of waste, during March of 2016.

During March on 2016, the Candia Recycling Center created 29 bales of recyclable products, which equals approximately 39,200 lbs, which equals 19.60 tons.

On March 16 the electronic container was swapped out, with 2.89 tons of electronics to be recycled.

The total amount recycled was 22.49 tons for the month of March 2016.

On March 4^{th} one load of paper and cardboard was marketed, there were 8,34 tons of cardboard that generated \$500.28. There was 14.27 tons of mixed paper which generated \$285.34.

On March 3rd, 18,520 lbs of #1-#7 plastics were marketed, which generated \$370.40.

Cemetery Sexton Job Description



The Cemetery Sexton reports to the Cemetery Trustees and serves as the general public's point of contact for matters relating to the cemeteries under the jurisdiction of the Town of Candia.

Specific duties include:

Show and Sell Available Lots to Prospective Buyers

- Ensure prospective buyers are qualified to purchase lots;
- Ensure applications for lot purchases are completed properly;
- Ensure Cemetery Rules and Regulations are provide to purchaser and appropriately documented as received;
- Collect payment for lot sales and deliver payment to the Town Clerk;
- Order corner markers and ensure their delivery and proper installation.

Coordinate Buy Back of Cemetery Lots

- Ensure interested party has proof of ownership of deeded lot;
- Inform interested party of buy back process.

Coordinate Casket and Cremation Burials

- Serve as point contact for family members and for Funeral Home;
- Coordinate for use of tomb if required;
- Meet with family members to confirm grave location for burial;
- Mark grave location appropriately and arrange for digging of grave;
- Upon completion of burial, ensure grave is appropriately closed and gravesite condition is returned to a satisfactory condition;
- Ensure receipt of Burial Certificate and provide original to Town Clerk and a copy to the Bookkeeper of the Cemetery Trustees;

Coordinate with Monument Companies

- Provide Monument Application Permit Form to Family;
- Ensure monuments and/or flush markers requested by the family meet permit requirements;
- Ensure headstones and/or flush markers are installed in the proper location;
- Coordinate with Branches of Military for the delivery, placement and installation of military markers. Perform installation of military marker(s) if necessary.

Other Duties

- Manage and oversee the work of the Cemetery Groundskeeper to ensure cemeteries are appropriately maintained. Provide assistance as necessary;
- Coordinate volunteer activities at the cemeteries;
- Coordinate opening and closing of cemeteries as determined by weather or other factors;
- Maintain one set of keys to the maintenance shed, cemetery gates, and tombs;
- Maintain an inventory of cemetery equipment. Ensure mechanical equipment is maintained per manufacturer's requirements.
- Respond to requests, calls and complaints from residents and visitors and refer unresolved issues to the Cemetery Trustees;
- Develop and implement maintenance and improvement plans for each cemetery;
- Provide monthly reports to the Cemetery Trustees;
- Attend Cemetery Trustee meetings when requested;
- Performs other duties as assigned by the Cemetery Trustees.
