



On 7/22 there was a paper/cardboard trailer swap. There was 12.57 tons of paper which generated $\underline{\$439.95}$ in revenue and 9.06 tons of cardboard which generated $\underline{\$679.50}$ in revenue.

On 7/29 there was **9.46** tons of Scrap Metal recycled that generated **§717.45** in revenue.

There was a total of \$1836.90 in revenue generated during July 2016.
