MEMORANDUM

Subject: Special Detail Rate Increase Request
Date: April 17, 2017
CC:

I would like to raise the amount of the officer portion of the special detail rate from the current \$35.00 per hour to \$40.00 per hour for the officer, which is still below the average of the Agencies used in the comparison (see below). Currently, we bill the entity \$55/hr. I am requesting this be adjusted to \$60.00/hr; therefore still allowing \$20/hr to go into the special detail account.

Candia - \$55/hr. (Officer gets \$35/hr. – \$20 goes to Town)
Auburn - \$57/hr. (Officer gets \$40/hr. – \$17 goes to Town)
Chester - \$59/hr. (Officer gets \$39/hr. – \$20 goes to Town)
Deerfield - \$60/hr. (Officer gets \$40/hr. - \$20 goes to Town)
Northwood - \$69/hr. (Officer gets \$40 - \$29 goes to Town)
Nottingham - \$60/hr. (Officer gets \$40/hr. - \$20 goes to Town)
Raymond – \$72/hr. (Officer gets \$40.25/hr. - **if Officer makes more than \$40.25 in OT, he gets his OT rate)
Rockingham County Sheriff - \$68/hr. (Deputy gets \$43/hr.)
SP- \$74/hr. (Trooper gets \$52.93/hr.)

There has been no increase in the Officer's hourly rate since 2009, which was \$30.00/hr. to \$35.00/hr. I believe that we need to review and adjust this rate on an annual basis. I think that by having a reasonable detail rate, as well as other benefits, is an incentive to retain officers and to be competitive when hiring new officers.
