Public Input Hearing on Proposed Town Budget

Public hearing was opened at 7:02 pm.

Mike Kelly, Fire Department Captain pointed out that the ambulance wages change is up by \$30,000 because it was cut last year, and he added it back. He also added a bit for week-end stipend.

Brenda asked the Police Chief if they got the cost for the new cruiser. The cost is \$48,000+.

Bob Stout asked the Department heads to speak about where they can cut 2% or 3%.

Fire Chief Young said he does not want to cut his budget.

Road Agent – Jeff Wuebbolt said there is nowhere for him to make a cut. Lynn asked if the money for the Block Grant can be used for anything they want. Jeff said it must be for Highway. She then asked if they get \$100,000 from the Block Grant, can they remove that amount from the budget. Jeff stated that if they get the revolving fund with the warrant article, it would work like the Highway Fund. He would have to bring a request to the Selectmen for a highway project. The warrant article will let them take on more projects or do projects that cost more than the average project. Money not spent will remain in the revolving fund and accrue from year to year.

Chief McGillen stated that they are giving out \$15,000 for new hires to try to entice people to come to Candia. Those funds were not budgeted this past year and they will need to come out of somewhere. There are some conditions. They are going to try to encumber some funds this year to help pay for the cruiser. He won't know until the Selectmen vote on it.

Brenda asked about the resource officer. The Chief said it comes out of the School Dept. budget. Carla Penfield said the Police Dept. budget shows \$208,000 left in this year's budget. Does that mean there will be money to encumber for the cruiser?

Lynn said maybe but there is still more time in this fiscal year for expenses.

Chuck Whitcher said the recycling center budget will be down a little bit and they have one big project coming up but they may be able to take out a couple thousand.

Lynn said they have a capital reserve fund. Can they take some of the money for repairs on the equipment. Chuck said he is not sure what is in that fund or for what it can be used.

Susan Young spoke as a resident. She stated the Fire Department does not get paid; they get a stipend as a volunteer. They leave their jobs to go to calls. She wanted to let everyone know that they do not get paid.

Dean Young stated that is his complaint. He submitted a budget as low as he can make it. If the budget committee wants him to make a cut, they should tell him where to make a cut.

Bob Stout said the reason he is on the Budget Committee is to ask the questions. They are looking at an 11% or 12% increase so he asked the question of where money can be cut. If a department head said he cannot make a cut, just tell him that as the answer to the question.

Article 2 is the default budget of \$3,637,656.00.

Article 5 - \$30,000 for the Recycle Center Equipment and Capital Improvement Capital Reserve Fund. Carla Penfield asked what this is for. Jeff stated it is towards a loader they need to replace at a cost of \$100,000.

Article 16 for \$2,998,000 for a new Police Department Facility. We do not know the amount of interest. This number is the principle only. Carla Penfield said she did some numbers. In 2023, we added money for the ambulance. If the bond passes, we will add an average of \$300000 more to the budget. In 2023/2024 we will have increased the budget by \$600,000. The school will add another line that will add more than several hundred thousand a year for a lease. Lynn stated the school has had the lease in the budget for the past two years, and they have made three payments to date. Lynn said it requires a 3/5 ballot vote to pass.

Carla asked how they explain the warrant article to the public so they understand the true cost.

Russ Dann, said the construction would not start until the latter part of 2024 so there will be no utility costs etc. They will not be in the building until the spring of 2025. It will cost another \$300,000 each year it is put off.

Brenda asked how much has been spent to date for the land and the architect, etc.

Susan Young said it was paid from the Capital Improvement Fund.

Chief McGillen said they brought the total cost down as much as they could.

They question was raised as to how they can educate the residents, so they understand the warrant articles they are voting on. It's the same 40 people who show up at the deliberative session.

ARTICLE 2.

To see if the Town will vote to raise and appropriate as an **Operating Budget**, this operating budget warrant article does not include appropriations by special warrant articles and other appropriations vote separately, the amounts set forth on the budget posted with the warrant or as amended by vote of the first session, for the purposes set forth therein, totaling **\$4,028,677**. Should this article be defeated, the default budget shall be **\$0,000,000** which is the same as last year, with certain adjustments required by previous action of the Town of Candia or by law; or the governing body may hold one special meeting, in accordance with RSA 40:13, X and XVI, to take up the issue of a revised operating budget only.
