

April 2018

In April 2018 the Candia Recycling Center had Land-filled **61.51** tons of Municipal Solid Waste. The Recycling Center sent **41.70** tons C&D debris to a C&D recycling facility during April 2018. The Recycling Center processed **103.21** tons of waste in April 2018.

Recyclables

Mix paper – 14 bales = 22,665 lbs. = 11.33 ton

Cardboard - 8 bales = 11,204 lbs. = 5.60 ton

Tin Cans - 3 bales = 4001 lbs. = 2 ton

#1 - #7 plastics -3 bales = 3,574 lbs. = 1.79 ton

Aluminum Cans – 2 bales = 1,479 lbs. = .74 ton

#2 natural plastics -1 bale = 847 lbs. = .42 ton

The 31 bales created during April 2018 weighed 43,770 pounds which equals 21.89 tons. There was also 5680 lbs or 2.84 tons of electronics recycled creating a total of 24.73 tons recycled.

.On 4/20 there was **7.95** tons of Cast iron and #1 steel marketed which generated \$1313.17 in revenue.

On 4/27 there was **2500** lbs. of hi-grade dirty aluminum marketed which generated **\$525** in revenue.

On 4/26 there was **18,140** lbs. of #1- #7 plastics marketed which generated **\$362.80** in revenue.

The Candia Recycling Center generated \$2200.97 in revenue from the sale of recycled commodities. These funds have not yet been received by the Town, what has been accounted for as of 5/9/18 is \$8598.81 in revenue year to Date.

Recycling Center Loader

The 1998 Case 1845 C loader currently in use at the Recycling Center, which has been approved for replacing, has recently developed a fuel leak. The leak appears to be coming from the fuel pump. We do not want to expend any funds on repairs for this machine, so I have been working on finding a replacement. This is summary and recommendation for a replacement machine.

I reached out to three manufacturers to get a price quote and to get a test unit delivered to the facility. The three companies are Case, JCB, and Bobcat. We were able to use all three machines down at the facility to make sure each unit was able to perform the all the necessary duties at the facility. One critical operational duty is being able to lift and dump the 4 yard glass hopper into the 30 yard open top container; this requires the machine to be able to lift a minimum of 3000lbs. The 1845 C cannot lift or dump the glass which leads to major issues if the JCB is not operational, which has happened. I am trying to equip the facility with a machine that can perform any and all tasks at the facility.

The first Machine is a Case SV 280 Skid Steer that was delivered from Beaurgard Equipment out of Concord. The machine was able to lift and dump the glass container, which it accomplished, but did need two people to perform the task – the operator cannot exit the machine with an object on the forks or if the arms are up. We also used the unit to make a bale of cardboard, the machine was physically able to maneuver within the building, although twice during the making of the cardboard bale, material became wedged between the door and the bucket so that the door would not open and the operator couldn't exit until the material was cleared away by another staff person. The cost of the Case SV 280 with the Case 1845 C as a trade in is \$51,952.

We also had a **Bobcat S740 T4** Skid Steer loader delivered from Bobcat of NH out of Chichester. The machine itself is physically large, the largest of the three test units, we were able to dump the glass with out issue, though it also needed an extra person to release the lever to dump the glass hopper. We also used the unit to make a bale of paper, which had some challenges due to its larger size. Most noticeable was the length of the machine, the "tail end" behind the operator, it is significantly longer than the other test units, which presents an issue while turning the unit. The swing could easily hit objects, which required an extra amount of attention from the operator to prevent damage. The vision within the cab is very limited, poor at best, the ability to see behind the operator is very difficult, the rear window is quite small and with the machines large stance, the operators' vision is quite limited. The cost of the Bobcat with the Case 1845 C as a trade in is \$51,797.52.

The third machine that was delivered was a JCB 3TS 8W skid steer. This skid steer has an extendable boom, similar to the 520-40 we currently own. JCB has a patent on this design and currently is the only manufacturer offering this option. This ability offers many benefits to our facility. First it is a side entry machine, this is important because when the machine is in use, with the arms up or with material or objects on the forks or in the bucket, the operator has the ability to exit the cab and not need the assistance of an additional staff member. The side entry also offers far greater personal safety for the operator as opposed to climbing up onto front of the machine, especially for an aging staff, some with physical limitations. The ability to have an extended boom will also allow both of our machines to do all of the tasks that are required. The extended boom allows the staff the ability to tamp down the open top dumpsters and crush them so that we are able fill each container to capacity so they are hauled out less often than if they are not crushed. We also have limited amount of space for brush, so we regularly push brush up into the pile. We also have to

regularly push back the metal pile off of the pavement, which having an extendable boom gives greater ability to manage both of these areas. Snow requires us to push back snow piles, which then needs to be brought to the snow dump and pushed over the edge, The case can help to make small snow piles, but cannot safely get close enough to the edge to remove the snow or push back snow piles like the our JCB 520-40 can with an extendable boom. When yard waste has to be removed, the Case 1845 C cannot load Dennis' dump truck, it can't reach high enough. When the Ash pile is removed, the Case cannot perform the task, again it doesn't have the reach to lift high enough and dump. These outlined tasks can only currently be preformed by one of our two machines, the JCB 520-40, because of the extendable boom. The JCB 3 TS 8 W skid steer has about 8' of extendable forward reach, the only skid steer with this ability. This machine also has the ability of 360 degree turning, like all skid steers, but the extendable boom feature would allow us to have two machines with the equal capacities for the all the duties at the recycling Center. Currently, we have one machine that can do everything needed and when that machine is down, it puts a strain on our ability to efficiently run the facility. The cost of the JCB 3TS 8W with the Case 1845 C as a trade in is \$65,000.

Even though the JCB is \$13,000 dollars more, it is a far superior machine for our application and over the projected 20 year use of the machine, offers tremendous value to the facilities operations. The machine allows for the operator to be able to enter and exit the machine while in use, eliminating the need for additional personnel. With aging staff the safety aspect of side entry is a significant consideration, especially during winter use when snow and ice make it hazardous entering and exiting the machine. The JCB also has by far the best operator vision. This machine does not have two arms parallel to the operator, that when in use are frequently eye level, thus making it difficult to be aware of the surroundings and any potential hazards. The JCB has a single arm that typically sits below the line of sight of the operator on one side

only. The opposite side of the operator is clear vision. Of course at times during the operation of the machine's arm would be in a position that would partially obstruct the operators view, but these times would be far less then the all the time obstruction of two arms parallel to the operator. Again, the JCB is the only skid steer machine on the market available with an extendable boom. After 13 years of using a machine with an extendable boom, our JCB 520-40 has an extendable boom, the advantages of being able to extend the machine's reach are invaluable. Lifting, dumping, pushing are all able to be performed to such a degree that a nonextendable boom machine can't even touch. The JCB also has the smallest physical stature of the three units we tested. This is important in our case because there is not a lot of room to maneuver within the building, especially while loading the baler, so a unit that has a smaller than larger footprint is by far better for the Recycling Center. The JCB is my recommendation for purchase.

The BOS has allocated \$65,000 for the purchase of a new skid steer loader at the Recycling Center. I am going to apply for a grant through the NH the Beautiful organization for \$5000. We have received grants from NH the Beautiful in the past for both of the balers and the grapple bucket, so I am confident that we would receive the grant this time as well. The JCB 3TS 8W skid steer will be able to perform all of the necessary tasks at the Recycling Center, unlike the Case and Bobcat. The JCB 3TS 8W skid steer is within our budget and this machine through the course of its life span will more than justify the additional initial investment. This machine will give the most bang for the buck and offers the greatest value for the Town.
