Candia's Selectmen's Public Meeting Minutes
February 5th, 2019

Attendance: Chair Susan Young, Selectman Russ Dann, and Selectman Boyd Chivers.
Absent: Vice-Chair Carleton Robie and Selectman Scott Komisarek.

4:15 p.m. Meeting called to order.

Board to address any warrant article changes that were made Saturday and consideration of re-voting.

Are you in favor of Article 30 as follows:

*To see if the town will vote to raise and appropriate a sum of \$5,800 for the purpose of building an **addition to the Swap Shop** at the Candia Recycling Center. Said funds to be expended under the direction of the Board of Selectmen. Submitted by petition. (Recommended by the Board of Selectmen by a vote of 3 to 0) (Recommended by the Budget Committee by a vote of 6-0)*

Selectman Chivers moved to recommend that the Board supports **Article 30** as amended at the Deliberative Session. Seconded by Selectman Dann. All were in favor. Motion carried.

Are you in favor of Article 32 as follows:

To see if the Town will appropriate \$1.00 (One dollar) to the Agricultural Commission (if said Commission is established) in a Trust Fund according to RSA 674:44-g and having the Agricultural Commission as agents to expend the funds in the said Trust. Submitted by petition. (Recommended by the Board of Selectmen by a vote of 3 to 0) (Recommended by the Budget Committee by a vote of 6 to 0)

Selectman Chivers moved that the Board support **Article 32** as amended at the Deliberative Session. Seconded by Selectman Dann. All were in favor. Motion carried.

Are you in favor of Article 33 as follows:

To see if the Town will vote to raise and appropriate the sum of Ten Thousand Dollars (\$10,000) for the implementation of the Master Plan per RSA 674:5 and future planning for Municipal Capital Improvement projects. (Submitted by the Planning Board) (Recommended by the Board of Selectmen by a vote of 3 to 2) (Recommended by the Budget Committee by a vote of 5 to 4)

Selectman Chivers moved that the Board support **Article 33** as amended at the Deliberative Session. Seconded by Selectman Dann. Chair Young thought if they could coordinate with the School, the Planning Board and the Selectmen she thought she could change her vote and support that \$10,000 for planning. As long as it is done as a group and they are productive. All they did is take the word "and" out. She clarified this was for the Master Plan. Chair Young called for a vote. All were in favor. Motion carried. Chair Young confirmed that Selectman Chivers was going to change his vote on that and let the voters decide. Selectman Chivers confirmed that he changed his vote.

Selectman Dann moved to adjourn at 4:20 pm. Seconded by Selectman Chivers. All were in favor. Motion carried.
