



## January 2019

The Candia Recycling Center had land-filled **55.15** tons of Municipal Solid Waste (MSW) during January 2019. The Recycling Center disposed **13.18** tons of C&D debris. The Center processed **68.33** tons of waste during January 2019.

### **Recyclables**

Mix paper – 9 bales = **13,844** lbs. = **6.92** ton

Cardboard – 11 bales = **15,108** lbs. = **7.55** ton

#1 - #7 plastics – 3 bales = **4,193** lbs. = **2.10** ton

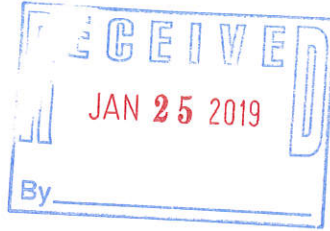
Aluminum Cans – 1 bales = **1020** lbs. = **.51** ton

Glass - 1 load = **20,280** lbs. = **10.14** ton

There were 26 bales created during January 2019 that weighed **37,060** lbs. = **18.53** tons. The total amount of material recycled during January 2018 was **57,340** lbs. = **28.67** ton.

The Recycling Center was awarded a \$5000 towards the purchase of the new Skid Steer from N.H. The Beautiful organization, we have received the check.

My name is Robert Sanborn; I am the current owner of record on M/B/L 413-010-001 Land Only located on Murray Hill Road in Candia which is adjacent to my property in Auburn NH. I have become aware since my father's passing that there is unpaid debt on this lot I have inherited.

Unfortunately during the transfer of ownership these debts were overlooked. I am not opposed to paying debt that occurred during my Fathers ownership of said lot but I am in hopes that we may come to a reasonable solution to resolve this debt. If you could eliminate the interest due as I would have paid the original billing invoices if I had been aware they were not paid.

These invoices date back to Mrs. Gordons passing and subsequently her estate transferring ownership back to my Father, Alfred N. Sanborn Jr., I believe this occurred in the spring of 2013. If I had been aware of these bills at the time they were due I would have certainly paid them on time. If you would accept payment of \$353.97 to clear these Liens it would be very much appreciated.
