As per our conversation at the September 17, 2021, Board of Selectmen's meeting, I recommend a wage increase and adjusting the special detail rate to be competitive with surrounding police departments.

I have spoken with my liaison Russ Dann, who agreed that giving the officers a \$1.25/hour increase effective immediately. I averaged the two bordering Towns of Auburn and Chester and came up with \$24.77, which is a \$1.77 per hour higher than our highest paid new officer, \$23.00hr.

This proposal would affect Seven (7) officers (I have not included myself). The cost would be approximately \$5500 for the remainder of the 2021 year. Approximately \$26,000 would need to be added to the 2022 budget
