

Re: Recommendation for reimbursement of application fees (ZBA case #:21-010)

The ZBA recommends to the BOS, by a unanimous vote, a reimbursement of \$274.98 in application fees for case #:21-010. This case came before the ZBA on 10/26/21 for special exception approval for a previously constructed ADU prior to 1996.

After further research with the State of NH as well as the legal advice given to the Board, it was determined that this case should not have been required to come before the ZBA.

In 2017 the State adopted RSA 674:72 II, which legalized any ADU constructed prior to the city/town's adopted zoning ordinance. Candia did not adopt their ordinance for ADU's until 2003, and therefore, the applicant's unit was already legal.

This recommendation ensures consistency with the current State RSA's and since the ZBA does not currently have its own escrow account for revenue and their funds are handled by the BOS in the general fund, the Board asks that this request be approved, and the applicant reimbursed immediately.
