OTHER BUSINESS:

Town Owned Properties: Selectman Chivers presented the Board with his memo along with a list of Town owned real estate with the intention of selling them. This is something he had brought up in a previous BOS meeting. Through the years, many of the properties listed were acquired by the Town from tax deeds of when people did not pay their property taxes and the Town foreclosed its lien.

Selectman Chivers said his request to the Board is to confirm their intention of going through with a public auction sale on some of the properties listed on Schedule 2. They are properties that are not being used for any conceivable purpose nor are they under the jurisdiction of the Conservation Commission. He said once the Board has confirmed their intention to go through with it and to setting up some type of system where they identify the Schedule 2 properties that they want to sell and then to authorize him to contact the company that sells tax deeded properties and arrange with them to get this process started. The company is called N.H. Tax Deeded Property Auctions and they are auctioneers and attorneys, so they manage the whole process. We will need to give them a list of the properties we want to sell and they will produce a map of the entire Town that will be color coded with each of the lots. They will send a notice to each of the abutters, complete all the title work, conduct the auction and then turn the proceeds over to the Town. He indicated it will be no cost to the Town as it is the successful bidder that pays the 10% buyer's premium. The Board will need to decide if they want to set up a minimum bid price on some of the properties. The first step they need to do, is to meet with the company, interview the company, make a recommendation, hire them and let them start working.

We will need to identify the properties we want to sell, then give the Conservation Commission a copy of the list and ask them for their input.

Selectman Young questioned some of the Properties and asked for a map of them. Selectman Chivers said they need to be careful of the properties they put up for sale. Chair Brock said this is a good idea and thanked him for looking into this and said he agrees in pursuing it. Discussion ensued.

New Employees: Town Administrator Spencer said we now have two new employees that began working at the Town Hall Office as of March 24th, 2025, they are Land Use Coordinator Megan Ross and Accounting & Payroll Specialist Tamera Peek.

OTHER BUSINESS:

Retirement Plan: Chair Brock said this year the Board will be working on the Retirement plan for all employees. He indicated that it will be in the budget for this coming year.

Selectman Moran asked if anyone had sent out thank you letters to the applicants that applied for the open job positions. He mentioned one person that came in to apply and never heard anything back. He would like someone in the office to send out thank you letter and we appreciate their interest to all the people that have applied. He said some of the applicants could be a viable source in the event one of our employees is on vacation. Town Administrator Spencer said our Building Inspector has told her that he has a plan and a mutual agreement with the Town of Raymond.

Selectman Young said the Budget Committee would be happy if the process started sooner. Selectman Helmig said she thinks the Budget Committee needs to look at the last year's budget and understanding it more before the new one is presented to them.

The Board welcomed Selectman Helmig aboard as the new Selectman.

Selectman Chivers said he was very pleased with the results from Town Voting. The Town showed a lot of support for the Board. All their Budget items passed and all but one of the Warrant Articles passed. There was a conversation regarding Warrant Article #8 for the reconstruction of Fieldstone Lane that did not passed. Chair Brock said this should have been placed in the Road Agent's Maintenance Budget Line instead of a separate Warrant Article. Discussion ensued.
