
Our 2025 Preservation Achievement Award winners were unveiled at the Tilton School on Wednesday, June 11, 2024.

The 1932 National-Register Smyth Memorial Building faced an uncertain future when the Smyth Public Library moved to a new location.

The Candia Heritage Commission, with the help of the NH Preservation Alliance, developed a restoration plan. Although townspeople had previously voted favorably for the reuse of the building in the master plan, funding for its renovation was defeated by town vote.

Recognizing the long-term need for repair and upgrades, the Board of Selectmen formed a Board of Trustees in 2014 dedicated to maintain and preserve the building and its grounds. The Trustees began with restoration of the windows and have continued with regular, substantial stewardship projects with support from the Selectboard and Town.

However, the building was vacant until a few years ago when Jesse Remington High School made a major commitment to upgrade systems to make use of the building possible for both the school and the town. The commitment of the building's Trustees, approvals by the Town Board of Selectmen and donations from area contractors made the transformational project possible in a very short amount of time. The Trustees maintain a clear commitment to care for the landmark's character-defining features like its slate roof, original windows, cork floor, majestic oak woodwork, and historic and commemorative fireplace mantle.

Like many great preservation projects there is an interlocking partnership here, we're recognizing both the Town's stewardship as well as for the School bringing renewed life to Candia's village center -- not only with its use of the Smyth Memorial Building, but also with its use of the Candia Congregational Church, a one-room schoolhouse and 19th century homes on nearby Stevens Lane that all together make up a wonderful campus of creative learning spaces for their students.

A signature program of the School's Project Based Learning is timber framing, where students are engaged in the construction of a building, from design to finish using their campus' historic barn as their workshop. Jesse Remington High School has built over 50 structures now standing across the state of New Hampshire. Here's to more great stewardship and partnerships.



Barn Preservation Easement 187 North Rd., Candia, NH 03034 Map 406 Lot 025-2 Per RSA 79-D

Monday, August 11, 2025 6:30pm Candia Town Hall – Selectmen Conference Room

The Candia Board of Selectmen will hold a public hearing to consider input on an application for a discretionary barn preservation easement for an historic structure. If approved, the property owner would be eligible for a discretionary easement for 10 years and potentially receive a discount ranging from 25% to 75% of the assessed value of the barn.

Under NH law, a discretionary preservation easement shall be considered to provide a demonstrated public benefit if it provides at least one of the following:

- (a) There is scenic enjoyment of the structure by the general public from a public way or from public waters;
- (b) The structure is historically important on a local, regional, state, or national level, either independently or within an historic district;
- (c) The structure's physical or aesthetic features contribute to the historical or cultural integrity of a property listed on or determined eligible for listing on the National Register of Historic Places, state register of historic places, or locally designated historic district.

Any interested person may attend this public hearing and submit testimony or opinions related thereto.

Town of Candia Energy Update

1. Municipal Electricity Supply Contract

Purpose: Covers electricity supply for town facilities (e.g., Town Hall, Police Station, Fire Department, Library, etc.).

Status: Current supply contract expires in November 2025.

What's Needed / Pending:

- Begin collecting competitive supply pricing now.
- Review renewal options with the Select Board.
- Make a selection before the current contract expires to ensure continued coverage.

2. Group Net-Metering with Hydro Facilities

Purpose: Provides additional savings on electric costs to town accounts by participating in a group net-metering arrangement with hydroelectric generators.

Status: The current net-metering agreement also expires in November 2025.

What's Needed / Pending:

Decide whether to renew or modify the agreement before November.

3. Community Power Program

Purpose: Provides residents and small businesses with additional electricity supply choices — often at rates lower than the utility's standard offer or with additional renewable energy.

Status: Program approved; awaiting refreshed supplier pricing before moving forward.

What's Needed / Pending:

Await updated pricing from suppliers.

EPO Energy Profiler Online TM - Service Agreement

Eversource will provide interval meter data via an access protected web site. At least one interval recording meter is required per account and the customer must be billed on the utility rate GV or LG. Eversource and any third party contracted by Eversource will not disclose any customer confidential information including customer name and address, metering, billing and pricing, power usage, business activities, and other customer information without prior consent from the customer. Eversource may, at our discretion, cancel this agreement and return the unused pro-rated portion of fees received. Upon receipt of the completed Service Agreement, data will be provided within 2 business days. Additional time may be needed for large requests.

The EPO service is not intended for billing comparison purposes.

This Service Agreement can be used as a letter of authorization by energy brokers and consulting companies to request non-interval usage histories for customers billed on the utility rate GV or LG and for icap tag data for all utility billed rates.

All interval data available at the time of the request will be provided online. Data will not be updated. The user id and password will expire 30 days after the start date of service.
