Regular Business:

1. Minutes of previous meeting - Tabled
2. Wetland Permit Applications -None
3. Land Use/Wetlands/Enforcement Issues – 23 Main St. is on hold. -New Boston Road (Foster Farms) Jim Logan will be on the agenda for the next Planning Board meeting, asking for waivers on his proposed elderly housing.
4. Correspondence -Betsey Kruse has decided to resign after 20+ years on the commission. Chair Judi read her resignation letter. Accepted with deep regret. -Other correspondence -Conservation easement monitor report on Sanborn Farm on Chester Road was done by Rockingham County Conservation District. They hold the easement on this property. There were no violations. -Other correspondence -285 Old Candia Rd. Pre-plan approval and what the restoration was. -Correspondence from Lamprey River Advisory Committee concerning the Foster Farm DES application for the elderly housing on New Boston Rd. They were asked to review this and noted there was no Natural Heritage Bureau report included which would indicate species in and around this sensitive are, according to the Wildlife Action Plan for Candia. It should be noted that this area borders the North Branch of the Lamprey River and is considered to be an area of the highest rank in biological habitat diversity in the state of NH. The Natural Heritage Bureau report would tell what is most at risk. -Other correspondence -An invoice from the NH Association of Conservation Commissions for annual dues for 2023. Dick made a motion to pay the membership dues. Chair Judi seconded. The annual meeting of the NHACC is Nov. 5th
