# April 16, 2024 Meeting Minutes – Approved

Public comment: Bob Panit was invited to attend as Emergency Management
Director regarding the access to public land and gate access for emergency vehicles.

Bob said that regarding vehicles having access usually an ATV (all-terrain vehicle), would be used for emergency situations for rescue and police. Forest fire is a different kind of scenario. The funds will come taken from the education fund.

6. Conservation Easements/Water Resources –The warrant articles that were recently passed are two areas to start working on with Bear Paw. On the Dennis Lewis Forest property and the other town properties that are being combined in the easement- we need to establish the boundaries. Tax maps are not the same as what present town maps show. The other two properties that are being combined into one easement also have a similar kind of problem. More information will be needed.

7. Forest Management -Flint Road- Ron has a design idea about the basic layout and what will be required. The design and layout are a good place to start and Ron can proceed with having Jeff give us a figure for doing this.
