**Regular Business:**

1. Minutes of previous meeting – Carol made a motion to accept the minutes as presented. Tom seconded. Leon abstained. All in agreement. Motion passed.
2. Wetland Permit Applications - none
3. Land Use/Wetlands/Enforcement Issues-An informational meeting about a potential development on Crowley Road will be held at the school on Nov. 20<sup>th</sup>.
4. Correspondence – A letter from the Southeast Watershed Alliance

7. Forest Management – Ron is going to attempt to remove the large tree that is across the blue trail on the Deerfield Road Town Forest. The Troop 120 Scouts of Candia worked on the trails there, clearing brush and other general maintenance.
