Feb. 21st, 2019 Approved Cemetery Minutes

<u>Present:</u> Chair Holly Haas, Bookkeeper Lorraine Meuse, Dick Snow, Tom DiMaggio, Sexton Martin McFarland and Administrative Assistant Donna Del Rosso. Absent: Carleton Robie.

Meeting called to order @ 6:30 p.m. by Chair Holly, followed by the 1. Pledge of Allegiance.

Regular Business:

- 2. Previous Minutes: Bookkeeper Lorraine motioned to accept the minutes as amended. Dick second. Motion passed. Tom and Sexton Martin abstained.
- 3. Monthly Operational Status Report: Sexton Martin reported the estimate to repair the front gate is \$700 and will be fixed when weather permits. No bodies currently in the Tomb. Lucille Walker is the only deceased reported, burial will be in the Spring.

Dick received from the NH Correctional Institute a quote for the (4) street signs 2-Main St., and 2-Center St. Tom motioned to purchase the 4 signs @ \$119 from NH Correctional Institute, Bookkeeper Lorraine second. Motion passed unanimously. Administrative Donna pulled up pricing from Swenson's Granite for members to discuss (12" x 12" x 7') \$959 -4 sided cut or \$ 285 -2 sod faced. Members will discuss other options next meeting.
- 3. Socha Tombstone Erosion Tabled until Spring.
- 4. 3 Cemeteries Abandonment BOS has made public notice in 3 different places, discussion will be March 18th meeting. If no one responds the Cemetery Trustees will become guardians and proceed with putting the information on the deeds.
