**Other Business**

**ZRRC Committee Update**

Chair Girard asked if the ZRRC wanted to have a workshop meeting with the Planning Board in November. S. James said the ZRRC has 2 more meetings with Jack Munn in October and November and will be ready for the Planning Board in December. They are working on both ordinance and regulation changes.

**NHDOT Aerial Photography**

S. James said the NH Dept of Transportation (NHDOT) is coordinating with the US Geological Survey (USGS) to acquire high resolution, leaf-off, color, aerial photography in high pixel resolution imagery for the entire state. Data will be collected in the spring of 2010, with final products available in approximately 6-9 months. Towns can opt to buy in if they want to pay extra for a closer view up to 2 ½ feet to scale which is very accurate. Candia’s cost would be \$6,000 to \$9,000. S. James said he felt this was beneficial for many committees in town. He said there was a letter on the website dated 9/15/09 that was sent to each community and he was wondering if the Town had received the letter. Chair Girard said the budget has already been submitted for 2010 but a warrant can be submitted to cover the cost or the cost can be submitted in a future Planning Board budget when the state does the photography again. S. James to follow up and obtain a free copy for the Town.

**Law Lectures Oct. 14, 21, 28**

Car pooling was discussed. Chair Girard, J. Lindsey and G. Clifford will carpool together for the 14<sup>th</sup>. Changes to schedules were made due to other committee meetings conflicting.
