The notarized Lot Merger document is to be recorded at the Registry of Deeds and all fees paid to the Town of Candia if we are recording it for you. If not, please provide the Town with a copy of the recorded document or at least the Book and Page of the recorded document, for our records.
- 7. Map 409 Lot 206 to be merged with Map 409 Lot 207-1 within 60 days.
