### **Special Town Meeting Warrant Article**

To see if the Town will vote to rescind the votes at the 2002 Town Meeting on Warrant Article 31 and at the 2005 Town Meeting on Warrant Article 18, creating the North Road Town Forest and assigning the Candia Conservation Commission with the care, management, and control, of those two properties shown on the current Candia Tax Maps as Map 402 Lot 008 and Lot 009, and further, to authorize and encourage the Board of Selectmen to negotiate an equal-value swap of the ownership of said Town properties with South Branch Brook Holdings, LLC, in exchange for the ownership of three of their properties on Raymond Road, two of them shown on the current Candia Tax Maps as Map 409 Lot 96 and Lot 97 and the third one a 1.54 (+/-) acre portion of Map 409 Lot 96-1 abutting the said first two Lots. Further, The Candia **Conservation Commission is hereby authorized to place** conservation easements on the Flint Road Town Forest, Map 410 Lot 010, and the Hemlock Drive Town Forest, Map 412 Lot 003 and Lot 004.

This is a special Warrant Article. If the Warrant Article is approved, but the intent of the equal-value swap authorized by the Warrant Article is not consummated on or before December 31, 2021, this Warrant Article shall be declared null & void, without compensation to either party.

#### Hello everyone,

The Planning Board is continuing our efforts to update and consolidate maps and data into an easily accessed and useful program. Maps include (but not limited to): Zoning, Conservation areas, Flood-prone areas, steep slopes and tax maps. Data includes (but not limited to): Building information such as Assessing data, building permits and related documents and, in the case of commercial operations, information for fire prevention data.

Our Town Engineering firm, Stantec, presented the Board with information for GIS (Geographic Information System). This software captures, stores, analyzes, and displays data in relation to location. This system gives access to information that can be uploaded into a system such as this and assist us in the organization of their information so as to better oversee conservation, utilities, forestry, locate and target specific zoning areas, natural resources such as flood zones and other wetlands as well as providing agricultural data, just to mention a few things.

A GIS requires gathering information from a variety of sources that include topographic maps, aerial photos, satellites, surveys, government research and reports, etc. and is regularly used in many towns to assists in cost savings, clearer communication and thus improved decision making based on the up to date information that is provided versus more outdated software that is currently used which does not have the capabilities to update or track these important items regularly.

In order to develop a plan of action for this project, the PB needs your feedback:

With the implementation of a GIS for the Town of Candia, how could the program assist your department, committee, board, Town residents as well as outside agencies or individuals you may work with? For example, potential areas of data include:

Conservation areas

- Tax map data
- Street repair rebuilding data
- Fire Department pre-planning
- Water supply locations and status
- Building permit history

The PB will be discussing this further at the August 4<sup>th</sup> meeting and request you or a representative from your organization attend that meeting for more details. It is critical that we have a representative from every organization in order to develop a solid proposal and long range plan. If you'd like to submit feedback prior to the August 4<sup>th</sup> meeting, please reply to this email directly to me, (please do not reply all) or you may also drop anything off in writing at my office before the 8/4/21 meeting during business hours (8:30am to 3pm) and I will provide it to the Board for review.
